

§ 95.30. PROTECTION OF LAKE PFLUGERVILLE.

(A) Hours of Operation. Except in cases of an emergency, other good cause for closing Lake Pflugerville and subject to the prohibited acts and regulations under the City of Pflugerville Code of Ordinances and Public Parks Ordinance section 95.05 specifically, Lake Pflugerville shall be open for public use as follows:

(1) All times, other than Peak Season, from 5:00 a.m. until 10:00 p.m., provided, however, that Lake Pflugerville shall be open 24 hours a day for the purposes of actively fishing when in possession of valid state fishing license as required by State Law.

(2) During Peak Season (which shall be defined as March 1st to September 30th), Lake Pflugerville shall be open for public use from 6:00 a.m. until 9:00 p.m. provided, however, that Lake Pflugerville shall be open 24 hours a day for the purposes of actively fishing when in possession of valid state fishing license as required by State Law.

~~(A) Lake Pflugerville shall be open for public use from 5:00 a.m. until 10:00 p.m., provided, however, that Lake Pflugerville shall be open 24 hours a day for the purposes of actively fishing and in possession of valid state fishing license as required by State Law; except in cases of an emergency or other good cause for closing Lake Pflugerville.~~

(B) The city manager, in case of an emergency, or other good cause, may close Lake Pflugerville.

~~(B) In case of an emergency, or other good cause, the city may close Lake Pflugerville when the city manager declares closing Lake Pflugerville to be appropriate.~~

(C) Motorized boats of any kind on Lake Pflugerville are prohibited, unless:

(1) The operator of the boat is authorized city staff, a county, state or federal agency, or has been otherwise authorized by city staff to use the motorized boat for a public purpose; or

(2) The boat is a fishing boat that is only equipped with an electric motor ~~with a primary source of power being electric~~ or an electric powered model boat.

(D) Horses are not allowed on the public lands or trails abutting or adjacent to Lake Pflugerville.

(E) Throwing, depositing, placing or dropping any materials (including glass containers) into Lake Pflugerville or on the land or trails abutting or adjacent to Lake Pflugerville is prohibited.

(F) Swimming in Lake Pflugerville is prohibited in the area between the buoys near the intake structure and the dam.

(G) Starting, creating, or maintaining a fire, except in a barbeque grill, is prohibited; except that use of a barbecue grill is prohibited pursuant to a state or locally enacted burn ban until such order expires or is terminated.

(H) Operating a motorized vehicle on the land or trails abutting or adjacent to Lake Pflugerville is prohibited unless the vehicle is being used for emergency or trail maintenance purposes.

(I) Bathing, urinating, or defecating in Lake Pflugerville or on the public lands or trails abutting or adjacent to Lake Pflugerville is prohibited.

(J) Camping on the public lands or trails abutting or adjacent to Lake Pflugerville is prohibited.

- (K) It shall be unlawful for any person, firm, or corporation to carry, possess, or drink any alcoholic or intoxicating beverage on Lake Pflugerville or on the land or trails abutting or adjacent to Lake Pflugerville.
- (L) The City of Pflugerville Noise Control Ordinance, Chapter 94, shall apply to Lake Pflugerville or on the public lands or trails abutting or adjacent to Lake Pflugerville, except under the granting of an application under section 94.07(B) of this Code for a temporary permit to operate any public address system or other amplified sound system.
