**Jennifer Griswold, Library Director**

Director Griswold reported that library stats are up in nearly every category. Program highlights from last month include: the Literary Ball, With the Banned Book Club and Baby Day Mini Conference.

Market and Outreach Coordinator Tiara Allen gave an update on marketing and outreach efforts for the library. She has been focused on promotion for the Summer Reading Program. We've received many requests for library outreach visits at local schools in the past month. She is also launching a social media marketing campaign for our electronic resources. Board Chair Robertson asked if any progress has been made on the library mascot idea. Coordinator Allen responded that she needs to discuss it with the city's communications department at this point and will keep the board informed.

The suggestion was made by Board Chair Robertson for the members to be more engaged with the Summer Reading Program and to help promote it.

**Friends of the Pflugerville Library**

Friends of the Library President Aaron Millis reported that the Friends held their annual membership meeting in April. At the meeting they recognized three library volunteers with Teen Volunteer Awards. The city's Facilities Committee has supported the renaming of the old section of the library as the Audrey Dearing Wing. This initiative spearheaded by the Friends will be on the City Council meeting agenda on May 27th for possible adoption. The next book sale is June 20th.
