RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS APPOINTING REPRESENTATIVES TO THE AUSTIN EXECUTIVE AIRPORT JOINT AIRPORT ZONING BOARD AND JOINT AIRPORT BOARD OF ADJUSTMENT

WHEREAS, the Austin Executive Airport is located within close proximity to the city limits of the City of Pflugerville; and

WHEREAS, the height and hazard area established by the Federal Aviation Administration (FAA) directly impacts land located within the City of Pflugerville and its extraterritorial jurisdiction (ETJ); and

WHEREAS, Chapter 241 of the Local Government Code establishes the ability for political subdivisions in which an airport hazard area is located to adopt, administer, and enforce under its police power, airport hazard area zoning regulations for the airport hazard area; and

WHEREAS, a political subdivision to whose benefit an airport is used in the interest of the public may create a joint airport zoning board with another political subdivision in which an airport hazard area is located as stated in Section 241.014(a) of the Local Government Code; and

WHEREAS, the joint airport zoning board must consist of two (2) members appointed by each of the political subdivisions creating the board as established by Section 241.014(c) of the Local Government Code; and

WHEREAS, the regulations established by the joint airport zoning board must provide for an airport board of adjustment as established by Section 241.032(a) of the Local Government Code; and

WHEREAS, the airport board of adjustment consists of five members serving two year terms per Section 241.032(c) of the Local Government Code and is composed of representatives of the participating political subdivisions; and

WHEREAS, the City Council finds that it is in the public interest of the City of Pflugerville to participate in the joint airport zoning board and airport board of adjustment; NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

- **Section 1.** That the facts and recitals set forth in the preamble of this Resolution are hereby found to be true and correct and are hereby adopted.
- **Section 2.** That the Assistant City Manager for Development Services and the Planning Director are hereby appointed the City of Pflugerville representatives on the Joint Airport Zoning Board for the Austin Executive Airport; and
- **Section 3.** That the Assistant City Manager for Development Services is hereby appointed the City of Pflugerville representative on the Board of Adjustment to the Joint Airport Zoning Board for the Austin Executive Airport.
