#### Regular Meeting

#### 1. Call to order

Mayor Jeff Coleman called the regular meeting to order at 7:03 p.m. Councilmembers Wayne Cooper, Jeff Marsh, Omar Peña, Starlet Sattler and Mike Heath were in attendance. Amy Madison, Executive Director of the Pflugerville Community Development Corporation was in attendance. Victor Gonzales, Mayor Elect; and Doug Weiss, Councilmember Elect were in attendance.
