Conduct a presentation on the FY26 Proposed Budget.

Mayor Gonzales opened the item for discussion. Ms. Waldron reviewed the strategic pillars, tax rate definitions, and property tax calculations. Ms. Waldron reviewed the general fund summary and sales tax revenues. Mr. Metayer asked about personnel changes. Ms. Breland provided information about changes and evaluating expenses. Ms. Ryan discussed refining estimates and debt rates. Mayor Gonzales discussed the growth of the city and where the city needs to go in the future. Ms. Waldron reviewed general fund budget reductions and answered questions from council. Mr. Weiss discussed the items being reduced. Mr. Rogers discussed debt interest rate and sales tax projections. Ms. Breland provided information about the vehicle and equipment replacement fund. Discussion followed regarding the fund versus leasing vehicles.

Ms. Waldron reviewed the hotel occupancy tax budget. Mr. Rogers asked about compliance with the short term rental program. Ms. Waldron provided information and stated there is an increase in compliance. Ms. Waldron reviewed the water and wastewater summary and provided information about rate requirements. Ms. Breland discussed water use in the city. Ms. Waldron reviewed the proposed rate adjustment and solid waste fund. Ms. Waldron discussed proposed changes to the purchasing policy to align with changes

from the state. Ms. Waldron reviewed the PCDC proposed budget and reviewed the city recommendations. Jerry Jones, PCDC Executive Director, answered questions from council regarding budget items and the IT support. Ms. Waldron reviewed next steps for the budget approval process.
