AN ORDINANCE AMENDING CHAPTER 153 OF THE CODE OF ORDINANCES FOR THE CITY OF PFLUGERVILLE, TEXAS, BY AMENDING THE THIRD POLICY CHAPTER OF THE 2030 COMPREHENSIVE PLAN TO UPDATE THE ELEMENTS OF THE OVERALL PLAN TO INCLUDE THE TRANSPORTATION MASTER PLAN DATED APRIL 2015; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The City of Pflugerville desires to adequately plan for transportation needs of the City as it continues to grow and expand; and

WHEREAS, the consultant, Brown and Gay Engineers Inc. was retained by the City of Pflugerville to develop the update to the Master Transportation Plan; and

WHEREAS, the City desires to incorporate the Transportation Master Plan as an element of the 2030 Comprehensive Plan, adopted in October of 2010; and

WHEREAS, Chapter 157 Subchapter 3.4 establishes the minimum procedures to amend the Comprehensive Plan; and

WHEREAS, the Planning and Zoning Commission held a public hearing to incorporate the Transportation Master Plan as an element of the 2030 Comprehensive Plan on April 6, 2015; and

WHEREAS, the City Council held a public hearing to incorporate the Water and Wastewater Master Plans as elements of the Comprehensive Plan on April 28, 2015;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

<u>Section 1. Chapter 153.01 COMPREHENSIVE PLAN of the Code of Ordinances of the City</u> of Pflugerville, Texas is hereby amended by adding the following:
