Regular Meeting

1. Call to order

Mayor Jeff Coleman called the regular meeting to order at 7:05 p.m. Councilmembers Wayne Cooper, Brad Marshall, Omar Peña, Starlet Sattler and Mike Heath were in attendance. City employees attending: Brandon Wade, City Manager; George Hyde, City Attorney; Karen Thompson, City Secretary; Lauri Gillam, Assistant City Manager; Trey Fletcher, Assistant City Manager; Tom Word, Assistant City Manager; Blake Overmyer, Building Official; James Hemenes, Parks Director; Chuck Hooker, Police Chief; Terri Toledo, Public Information Officer; Emily Barron, Planning Director; Jennifer Coffey, Library Director; Amy Giannini, Development Engineering Director; Pam Cosel, Special Events Coordinator.

2. Opening

A. Pledge of Allegiance to the Flag of the United States of America: I pledge allegiance to the flag of the United States of America, and to the republic for which it stands: one nation under God, indivisible, with liberty and justice for all.

Mayor Coleman led those in attendance in reciting the Pledge of Allegiance to the Flag of the United States of America.

B. Pledge of Allegiance to the Texas State Flag: Honor the Texas flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible.

Mayor Coleman led those in attendance in reciting the Pledge of Allegiance to the Texas State Flag.

Items were addressed in the order as recorded in the minutes.

3. Presentations

- 3A. [2016-4967](#)** Appreciation presentation to the members of the Charter Review Commission for service to the City from December 2015 to May 2016.

Mayor Coleman presented certificates of appreciation to the Charter Review Commissioners in attendance: Ron Sandford, Rudy Metayer and Tom Roland.

- 3B. [2016-4968](#)** Presentation of the 2015/2016 Charter Review Commission Report to

the City Council.

Mr. Sandford provided comments and indicated that full Charter Review Commission report was provided to the City Council in their packets. He offered to answer questions. Mr. Hyde provided information on the Charter review process. At their August 9, 2016 regular meeting, the City Council is scheduled to order a November 8, 2016 special election to bring forward the charter revision propositions to the voters for their consideration.

3C. [2016-4850](#)

Proclamation designating July 2016 as Parks and Recreation Month in the City of Pflugerville.

Mr. Hemenes provided information on the events scheduled for Parks and Recreation Month. Mayor Coleman provided comments on the current parks initiatives and the importance of parks as the heart of the community. Mayor Coleman read and presented the proclamation to Mr. Hemenes.

Pfirecracker Pfestival update.

Ms. Cosel provided information on the Pfireworks Pfestival taking place on July 4 at Lake Pflugerville and answered questions of the Council.

5. Public Hearing and Ordinance First Readings

Mayor Coleman indicated that he was opening the public hearings to be held on items 5C, 5D, 5E and 5F to be held simultaneously. He indicated that action would be considered on each item separately. He opened the public hearings and read the items to include the captions of the ordinances to be considered.

Ms. Gillam provided information. She stated that item 5C is for the issuance of certificates of obligation in an amount not to exceed \$9.38 million for a variety of projects. These include Animal Shelter Phase 1, Gilleland pool house and restrooms, Bohls House renovations, Pfluger Park restrooms, Police CAD/RMS software, the City's share for design of the SH 45 frontage road, 4 traffic signals, Public Works field crew building and infrastructure, and land acquisition. She stated that 5D is for issuing general obligation bonds approved in the 2014 election in an amount not to exceed \$29 million; issuing general obligation bonds approved in the 2015 election not to exceed \$2.93 million and issuing refunding bonds not to exceed \$15.8 million. She stated that item 5E is to issue nontaxable certificates of obligation to be paid for by (TIRZ) Tax Increment Reinvestment Zone proceeds in the amount not to exceed \$6.3 million for developer project reimbursements and 5F is to issue taxable certificates of obligation to be paid for by TIRZ proceeds in the amount not to exceed \$1.6 million for city project reimbursements.

Bart Fowler, bond counsel; and Spencer Day, financial adviser; were in attendance. Mr. Day provided information, noting an approximate \$5 million in savings over the term with the refunding bonds.

The following spoke at the public hearing:

David Wodrich, 3300 Heron Call Trail, noted a need for signage for those in the left-hand lane going north on FM 685 toward the Stone Hill shopping center cautioning them regarding upcoming standing traffic. He spoke regarding the senior center, that they have gotten bigger. He stated that most senior centers

are individual buildings. He indicated concerns for the grade of the new senior entrance. He spoke regarding the multi-use building not working well for the senior center. He recommended that they look at it again before making improvements to the building.

Steve Morrison, 1214 Pfennig Lane, indicated that he served on the senior advisory task force and is thankful for the progress. He stated that he realizes it leaves them inadequate, but thinks that moving the parks office out and kids upstairs provides improvement. He stated that he thinks the senior park jumped up in priority more than it should be. He stated that he thinks that re-evaluating that would be well advised. He mentioned that the access and grade needs to be better for senior drop off.

Jim McDonald, 1014 Duke Cove, stated that he is grateful for the Council pursuing the certificates of obligation, especially for the improvements to police communications. He stated that as the outgoing President of the Rotary Club, he is thankful for the City allowing their presence at Deutschen Pfest and he thinks making improvements to the restrooms at Pfluger park and Gilleland park is critical to our park jewel. He stated as the Vice Chair of the Parks Commission, that he is appreciative of seeing another step towards working with our senior population and making improvements to the Recreation Center.

Sandra Cunningham, 812 Valley Meadow, spoke regarding the importance of Gilleland pool to the community in providing swim lessons, safe swimming and swim team experiences. She spoke on her daughter's participation in swimming in Piranhas, Texas Gold, high school, as a life guard and swim instructor, and in college that have provided great experiences and life values. She noted the accomplishments of Micah Lawrence as an olympian. She stated the importance of improving the community pool and its importance to provide lifesaving skills. Mayor Coleman and Brad Marshall provided comments regarding Micah Lawrence.

Michelle Smith, 1111 Canyon Maple Road, stated that she supports the certificates of obligation and all the projects included in it. She stated that some would argue that this should have gone out to a vote, but they have elected the Council to represent them and these projects will make lives better and make a significant impact on the community. She encouraged the Council to continue to vote for the betterment of the community.

Barbara Woodworth, 809 Windsor Castle Drive, thanked the Council for the certificates of obligation. She stated that she really appreciates the step forward they are taking with item 5C. She stated that she supports the animal shelter and also the seniors. She stated that that they need to take the first step for the animal shelter and the seniors; that this is important to the residents.

Christie Crouch, Chair of the Parks Commission, spoke in support of the parks projects. She stated that it is a step forward for the seniors and she wants them to know that we are making them a priority. She stated that Gilleland

park is a jewel and is a show piece for visitors. She stated that nice facilities show how much we care for the swim program.

Mary McKenna, 119 Brooke Street, Hutto, Texas, stated that the animal shelter has changed her life and the lives of others. She stated that a therapist reached out to her this week for a therapy dog and they found a nice dog and through the work of volunteers, collected the pet deposit. She stated that the owner was able to get the service dog, as well as a gift basket. She stated that everyday something amazing happens at the shelter. She thanked the Council for approving this funding.

Carol Michel stated that they cannot have the senior room expanded until the parks offices are out and the Bohls House is done. She stated support for the approval of the certificates of obligation for the seniors, so the project can move forward.

There were no additional requests to speak at the public hearings. Mr. Cooper made a motion to close the public hearings. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

Mr. Heath stated that he still does not care for the way we continue to bundle our projects and not look at them holistically. He stated that we have multiple needs and we are taking it in a piecemeal fashion and there could be other things we could consider; that we are not looking at all of the needs. All voted in favor. The motion carried.

Mr. Peña made a motion to approve as read. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

6. Public Comment

Hunter Pope, 19308 Orts Lane, stated that his parents own Mr. Pfranks. He stated that his father asked that he speak to the Council to ask for an increase to the \$15,000 budget for downtown.

Frank Dierkes, 1137 Kentra Drive, stated that he is not a fan of anyone up here (on the dais). He stated that he has left over 50 voicemails for the City Manager and several messages for the Mayor and Council and has not received a call back. He explained that his complaint is that the police department does not enforce people parking blocking the sidewalks and with left wheels to curb and it is unsafe. He stated concerns for wrong way drivers. Mr. Wade stated to Mr. Dierkes that city staff has responded to him at length on these items. Mr. Dierkes stated that that is not true. Mr. Wade stated that it is. Mr. Wade stated to Mr. Dierkes that he supports the Police Chief's approach in enforcement and the community is policed at an appropriate level. Mr. Hyde stated that since the item is not included on the agenda for discussion, they need to stop further dialogue at this time. Mr. Dierkes asked if he could ask

one more question. Mayor Coleman stated that he may not. Mayor Coleman stated to Mr. Dierkes that he has returned his call and talked with him and that this item is over.

The public hearings under items 4C and 4D were held simulataneously.

Mayor Coleman opened the public hearing items 4C and 4D to be considered simulataneously. Ms. Barron provided information and answered questions of the Council. She provided additional informaton on the senior park. Mayor Coleman asked if they could encompass shade structures in the park due to the heat.

Gary Robertson stated that he is elated with the passage of the certificates of obligation. He stated that they cannot go forward without the improvements being made to the Bohls House. He stated that it is his understanding that if they do not use the CDBG funds then it is gone. He stated that they will take a senior park and make it work.

Carol Michel stated that she moved to Pflugerville five years ago and the senior center has provided them with friends and activities. She stated that it has remade their life and is important. She explained that the senior room is very small. She urged the council to approve so they can expand the senior room. She encouraged them to include new furniture. She asked that they not let this grant be the last thing for the seniors.

Ms. Barron stated that they can use CDBG funds for affixed cablinets, and they would look at it.

Steve Morrison stated that he thought the senior park was well down on the list of priorities. He suggested including providing aqua exercise for seniors and retrofitting one of the existing pools. Mayor Coleman stated that they have already done that at the Windermere pool and he believes it was complete in February. Mr. Morrison indicated concern for the new walkway at the back of the recreation center. Ms. Barron provided information on the new ramp system and drop off area at the back of the recreation center. Mr. Morrison asked if they could get a lift. Ms. Barron stated that they can look into it.

There were no additional requests to speak at the public hearings. Mr. Cooper made a motion to close the public hearings. Mr. Marshall seconded the motion. All voted in favor. The motion carried.

Mayor Coleman opened the public hearing items 4A and 4B to be considered simulataneously. Ms. Barron provided information. Gregory Pope, 19308 Orts Lane, stated safety concerns for pedestrians in the area of Hodde Lane, Cele Middle School, the proposed elementary school and the Reserve at Westcreek. He stated that he would like to have crosswalks and a trail system. He stated that he understands that it is in the City's extraterritorial jurisdiction (ETJ) but possibly something could be done. He stated that once they straighten the S-curve, perhaps traffic control could be added to allow children to get to Avalon. He indicated there is an interest with the Reserve at Westcreek to partner. Mr. Fletcher stated that these are county roads and therefore it is a county issue. Mayor Coleman noted that Travis County is aware of the issues. There were no additional requests to speak at the public hearing. Mr. Cooper made a motion to close the public hearing. Mr. Peña seconded the motion. All voted in favor. The motion carried.
