

CITY OF PFLUGERVILLE
SHORT FORM CONTRACT FIRST AMENDMENT
(Construction and Non-Professional Services)

This First Amendment to a Short Form Contract is made by and between the City of Pflugerville ("City") and Kansas City Tree Care, LLC. ("Contractor"). City and Contractor may be referred to herein singularly as "Party" or collectively as the "Parties."

WHEREAS, the Parties entered into that certain Short Form Contract for emergency services for removal of limb and brush following a severe winter storm event on February 14, 2023 (the "Contract") in the amount of One-Hundred and Fifty Thousand Dollars and No Cents (\$150,000.00); and

WHEREAS, the Parties desire to execute a first amendment to that Contract to add more time and services due to the continuing nature of the response needed to clean up the limb and brush debris in the city in an amount not to exceed Five Hundred Fifty Thousand Dollars and No Cents (\$550,000.00); and

WHEREAS, it has become necessary to amend the Contract to modify the provisions for terms and duration; and

WHEREAS, it is necessary for the City to amend its agreement from time to time to comply with changes in state law relating to contracts of municipalities.

NOW, THEREFORE, premises considered, the Parties agree that said Contract is amended as follows:

I.

- I. **TERMS** shall be amended as set forth in the attached addendum to Attachment A for a total amount of Seven Hundred Thousand Dollars and No Cents (\$700,000.00)
- II. **DURATION** shall be amended to extend the end of the services as identified in the attached addendum to Attachment A.

II.

Except as amended hereby, the terms of the Contract shall remain unchanged and in full force and effect.

**ADDENDUM TO ATTACHMENT A
TERM, SCOPE OF WORK AND FEES**

Work is generally described as residential limb and debris collection and removal for one month of added services. The service period is for February 28, 2023 through March 13, 2023.

Services provided by Contractor will include residential roadside limb and brush removal on each in city and extra territorial jurisdiction home frontage Monday – Saturday for the duration of the service period.

Costs associated with services received will not exceed \$550,000 and will be invoiced as follows:

- Daily removal of limb and brush as described above cost is calculated at \$2,550 per truck daily for 12 days.
 - **\$2,550 (14 trucks) = \$35,700 (12 days) = \$428,400**
- Total not to exceed amount of \$550,000
