

ORDINANCE NO. _____

AN ORDINANCE AMENDING CHAPTER 153.01(D) OF THE CODE OF ORDINANCES FOR THE CITY OF PFLUGERVILLE, TEXAS, TO INCORPORATE RECLAIMED WATER IN THE FOURTH POLICY CHAPTER OF THE 2030 COMPREHENSIVE PLAN; TO UPDATE THE ELEMENTS OF THE OVERALL PLAN TO INCLUDE THE RECLAIMED WATER MASTER PLAN DATED JANUARY 2015; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The City of Pflugerville desires to adequately plan for reclaimed water needs of the City as it continues to grow and expand; and

WHEREAS, the consultant, DCS Engineering, Inc. (DCS) was retained by the City of Pflugerville to develop the a comprehensive Reclaimed Water Master Plan; and

WHEREAS, the City desires to incorporate the Reclaimed Water Master Plan as an element of the 2030 Comprehensive Plan; and

WHEREAS, Chapter 153.01(B)(4) relates to the Water and Wastewater policy chapter in the Comprehensive Plan; and

WHEREAS, Chapter 157 Subchapter 3(C) establishes the minimum procedures to amend the Comprehensive Plan; and

WHEREAS, the Planning and Zoning Commission recommended incorporation of the Reclaimed Water Master Plan as an element of the 2030 Comprehensive Plan on December 1, 2014; and

WHEREAS, the City Council held a public hearing to incorporate the Reclaimed Water Master Plan as an element of the Comprehensive Plan on January 27, 2015;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Section 1. Chapter 153.01 COMPREHENSIVE PLAN of the Code of Ordinances of the City of Pflugerville, Texas is hereby amended by adding the following:

(D) Comprehensive Plan Amendments.

(3) The document entitled "Reclaimed Water Master Plan dated January 2015" prepared by the consultants of DCS is hereby incorporated as the reclaimed water element of the Comprehensive Plan by Ordinance No. _____ adopted on January 27, 2015.

Section 2. Effective Date.

This ordinance will take effect upon its passage by three affirmative votes on the first reading; provided that this Ordinance will be posted and adopted at a subsequent meeting in accordance with the provisions of Section 3.15(d) of the City Charter.

Section 3. Severability.

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.
