Permitted with Limitations	Amenity Center, Cemetery/Mausoleum, Museum/Art Gallery
Specific Use Permit Required	School: Private or Parochial

Commercial Uses	Section 4.2
Permitted by Right	Golf Course and/or Country Club
Permitted with Limitations	Brewpub/Wine Bar, Daycare Facility, Dry Cleaning Minor, Financial Institution, Health/Fitness Center, Massage Therapy Licensed, Personal Services, Restaurant, Retail Sales and Services
