### 1 Call to Order

The meeting was called to order by Chairman, Naji Norder, at 7:00 p.m.

### 3 Public Hearing

**2010-0350** Hold a public hearing and consider an application by the City of Pflugerville to apply zoning to the Greenridge Subdivision associated with the 2010 3-year annexation plan as follows: the Single-Family Suburban (SF-S) zoning district is proposed for all lots within Greenridge Subdivision Phases 1-6, less and except that the Agriculture/Conservation (A) zoning district is proposed for drainage and water facility lots identified as: Lot 90 Block B, Phase 1; Lot 47 Block I, Phase 4; and Lots 27A and 27B Block L, Phase 6 Correction Plat; for a total of approximately 159 acres within Pflugerville, TX to be known as the 2010 Greenridge Annexation Zoning. The property is generally located along Cheyenne Valley Dr., between N. Heatherwilde Blvd., and Gattis School Rd. (REZ1011-01).

**Jeremy Frazzell presented this item, giving a history of the subdivision and the annexation in progress.**

**Staff recommends approval. The request conforms with the Comprehensive Plan.**

**Mr. Anker asked if the property the water tower is on, is it zoned agriculture and is that the proper zoning.**

**Mr. Frazzell answered that is appropriate zoning and it is maintained by Manville. The drainage easement and the detention lot is maintained by the Homeowners Association of Greenridge. So is the private parkland in the subdivision.**

**Jay Patel, vice-president of the Greenridge HOA, residing at 424 Boone Valley Dr, spoke. Mr. Patel would like to dedicate the park to the City as parkland. The HOA would like to and can maintain the park, but for tax purposes they do not want the lots the park is on to be set as single-family residential lots.**

**Mr. Fletcher noted that this dedication was not discussed in the annexation negotiations. Mr. Fletcher gave guidance to the Commissioners to call out the lots the park is on to be zoned Agriculture/Conservation and not zone it as Single-Family Suburban.**

**Mr. Anker made a motion to approve the zoning of the Greenridge Subdivision as staff presented with the exception that the lot the park is located on is zoned as Agriculture/Conservation. The lots are called out as: Greenridge Phase 2 Lot 2 Block G, Lots 32 and 33 Block G; and Greenridge Phase 6 Lot 1 Block G to be zoned Agriculture/Conservation. Ms. Taylor seconded that motion. All in favor. Motion carried.**
