Re: Consider for approval a resolution authorizing the City Manager to apply for and accept, if awarded, a 2024 Project Safe Neighborhood Grant award for \$99,600.00 from the Office of the Governor for the purchase of equipment and overtime funding for project support personnel to expand a license plate reader program for crime prevention, investigation and resolution of crime within the City of Pflugerville. There is no funding match for this grant from the City. Approval is also requested to authorize the City Manager to sign all necessary documents upon final approval of the City Attorney.

I. Background

- A. This will be a third-year grant.
- B. The Pflugerville Police Department is utilizing this funding to expand a license plate reader system to assist with crime prevention, investigation and resolution of crime within the City of Pflugerville along with personnel overtime compensation.
- C. The City currently has funding from the 2023 Project Safe Neighborhood grant to operate a system of this type. This grant would assist the Department with expansion of this equipment in strategic locations around the city.

II. Current Situation

- A. The Police Department seeks funding assistance from the 2024 Project Safe Neighborhood Grant award for \$99,600.00 to assist in the expansion of a license plate reader system. This is a one-year grant.
- B. There is no funding match for this grant.
- C. Deadline for filing the application with the Office of the Governor is February 9, 2023. The resolution will be added upon authorization.
- D. In the fourth quarter of 2023 the City will be notified by the Office of the Governor of the award approval decision.
- E. To access the grant funding, City Council must authorize the City Manager to apply for and accept the grant award if received.

V. Recommendation

Approve the resolution authorizing the City Manager to apply for and accept, if awarded, the 2024 Project Safe Neighborhood Grant award for \$99,600.00.

WHEREAS, The City of Pflugerville City Council finds it in the best interest of the citizens of Pflugerville, Texas that the Pflugerville Police Department – 2024 Project Safe Neighborhood Grant project be operated for one year beginning fiscal year 2024; and
