**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS ESTABLISHING
LEGISLATIVE PRORITIES FOR THE TEXAS LEGISLATURE INTERIM PERIOD**

WHEREAS, the City of Pflugerville recognizes the importance of engaging in the legislative process during the interim period to advance policies that support community growth and sustainability; and

WHEREAS, the interim period is critical for shaping legislative priorities, building relationships with lawmakers, and ensuring the City's voice is represented before the next legislative session begins; and

WHEREAS, the City Council has identified priority focus areas for the interim period; and

WHEREAS, collaboration with the state legislature, regional partners, businesses, and residents is necessary to promote policies that strengthen the City's economy and help guide the City's growth; and

WHEREAS, it is anticipated that much of the interim charges will propose changes that directly impact the health, safety and welfare of our citizens or impact municipal services and finances; and

WHEREAS, it is important to establish the City of Pflugerville's priorities and positions, communicate them to the legislature and advocate on their behalf.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

The following legislative priorities as presented in Exhibit A are adopted by the Pflugerville City Council for the interim period ending January 12, 2027 (First day of 90th Regular Session).

EXHIBIT A:

Interim Period Priority Areas

The City seeks to monitor interim charges and hearings related to economic development, economic development tools including Qualified Hotel Projects, annexation and Extraterritorial Jurisdiction (ETJs).

- Economic Development: Fostering economic growth remains a priority to promote job creation, support small businesses, and enhance local and regional competitiveness.
- Economic Development Tools: Programs such as Qualified Hotel Projects and others are essential for supporting tourism, generating local revenue, and creating jobs within the hospitality industry.
- Extraterritorial Jurisdiction (ETJ): The City's ETJ plays a vital role in guiding responsible growth, coordinating infrastructure, and ensuring long-term economic sustainability.
- Municipal Authority and Legislative Engagement: The City seeks to preserve its authority to govern the community, its residents, and its assets in alignment with strategic goals and long-term interests.

The City will monitor and oppose any legislation that:

- Conflicts with the City's strategic goals
- Erodes municipal authority
- Negatively impacts municipal operations
- Threatens the health, safety, and welfare of residents
- Imposes unfunded mandates or reduces revenues
- Diminishes the authority of the City and its elected Council to govern effectively

The City will monitor and support legislation that:

- Advances the City's strategic goals and priorities
- Improves health, safety, and quality of life for residents
- Responsibly increases revenues
- Strengthens the City's authority to conduct the public's business

The City is committed to fostering strong partnerships and supporting collaborative legislative efforts. It will support the legislative agendas of the following organizations, provided they do not conflict with the City's strategic goals or interests:

- Capital Area Council of Governments (CAPCOG)
- Pflugerville Chamber of Commerce
- Pflugerville Independent School District (PFISD)
- Capital Area Metropolitan Planning Organization (CAMPO)
