#### **Regular Meeting**

## 1. Call to order

Mayor Jeff Coleman called the regular meeting to order at 7:12 p.m. Councilmembers Brad Marshall, Omar Peña, Starlet Sattler and Mike Heath were in attendance. Councilmember Wayne Cooper was absent. Mr. Heath indicated that he had removed from the consent agenda because he wanted to hear how we are planning for striping and planning for the future. Mr. Word provided information and answered questions. Mr. Heath made a motion to approve the item. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

## 9. Resolutions-Removed from Consent Agenda

9A. RES-0313

Approving a Resolution Directing the Publication of Notice of Intention to Issue City of Pflugerville, Texas, Combination Tax and Revenue Certificates of Obligation, and Other Matters Related Thereto.

(Tax-exempt Certificates of Obligation, Series 2016A)

Mr. Wade provided information. Mr. Heath stated that he thinks that a number of the projects do not work with the strategic plan prioritization that the Council is working on. He stated that he thinks the projects need to be vetted together and prioritized. He stated that some are discretionary. Mr. Wade explained that these are projects that have been postponed previously and that these are his recommendations for what is absolutely needed. Discussion followed. Mayor Coleman stated that he thinks that the projects would be high on the strategic plan list. Mr. Heath stated that he would like to do a master prioritization. He stated that he thinks some of the projects do not fit with the priorities and that there would be other projects that would have a higher need. Mayor Coleman explained that some citizens priorities are the animal shelter or parks; that it is important to balance. Mr. Heath stated that they need to do it wholly. Mayor Coleman stated that they are working towards that, but that they have been talking about the pool house since October 2013. Mr. Heath stated that they need to extend money to its highest and best use. Mayor Coleman stated that the these are the highest and best need and important projects for the entire city. Mr. Heath indicated concerns for the tax rate. He stated that they do not have to do this right now. Mr. Marshall stated that they have been directing and guiding staff on this list and have narrowed it down to this particular list. He stated that it may seem that the list just appeared, but they have been discussing it for years. Mr. Heath stated that he wants to be mindful for the citizens. Mayor Coleman explained that the appraisals have been going up, which has caused taxes to go up. He stated that the city is only 20% of the tax bill and the city can only effect a small part. He stated that we need to take care of the needs that we see. Ms. Sattler stated to agree and indicated the importance of quality of life. Mr. Heath stated that he thinks that they should spend a little time on it and get it right. Mayor Coleman stated that they have spent time and he feels they have done their due diligence. Mr. Wade answered questions and Mr. Hyde provided input in the discussion to follow. Mr. Terrell Palmer, City Financial Advisor, provided information and answered questions. Ms. Good provided input.

Melody Ryan, 1012 Ripley Castle Cove, spoke against the use of certificates of obligation. She asked why it needs to be funded this way and not taken to the voters.

Victor Gonzales, 303 Wilbarger Street, stated that Mr. Heath and Ms. Ryan make a point. He stated that the Council did not ask the voters regarding Stone Hill and it was the right decision. He stated that perhaps these projects should be presented at a worksession and concerns addressed. He stated that these projects are needed and long over due and they make the community strong and a place citizens can be proud of.

Council dicussion continued. Mayor Coleman opened items 9B, 9C and 9D for consideration. Mr. Wade and Mr. Richard Donoghue, bond counsel, provided information on the reimbursement resolution under item 9B. Mr. Wade, Mr. Palmer and Mr. Hyde provided information on items 9C and 9D.

Mr. Marshall made a motion to approve item 9A as read. Ms. Sattler seconded the motion. The vote was: Mr. Marshall-yes, Mr. Peña-no, Ms. Sattler-yes, Mr. Heath-no. Mayor Coleman voted to break the tie vote. He voted yes. The motion carried.

Mr. Marshall made a motion to approve item 9B. Mr. Heath seconded the motion. All voted in favor. The motion carried.

Mr. Sattler made a motion to approve item 9C. Mr. Peña seconded the motion. All voted in favor. The motion carried.

**9D.** RES-0317 Approving a Resolution Directing the Publication of Notice of Intention

to Issue City of Pflugerville, Texas, Combination Tax and Revenue Certificates of Obligation, and Other Matters Related Thereto.

(Taxable Certificates of Obligation for TIRZ, 2016C)

Mr. Marshall made a motion to approve item 9D. Mr. Peña seconded the motion. All voted in favor. The motion carried.

## 11. Discuss and consider action

**11A.** 2016-4882 Discuss and consider action regarding the scope of the proposed animal shelter expansion.

Mr. Fletcher provided information on the proposed plan for shelter improvements and answered questions of the Council. Lt. Wilkes and Ms. McLendon answered questions regarding animal shelter statistics. Mayor Coleman called Michelle Smith to provide public comment, but she indicated that she no longer wished to speak on the item. Mr. Heath asked if this is the best location. Mr. Wade stated that this is the location that we have and this was the direction provided in December 2015. Mr. Peña made a motion to proceed with this plan. Ms. Sattler seconded the motion. Mr. Heath asked if they could look at other options in the future. Mr. Wade asked the Council if this is being considered a stop-gap measure. Mr. Marshall stated that they should always look at other options. Mayor Coleman stated that it would make no sense to spend this money and then look for a different location as one of their directions to staff. Mr. Marshall indicated to clarify that no, they do not direct staff to do that. All voted in favor. The motion carried.

11B. RES-0320 Discuss and consider action to approve a resolution in support of the City of Austin's Proposal to become a US Department of Transportation (USDOT) Smart City.

Mr. Fletcher provided information. Mr. Wade indicated that a presentation regarding transit is planned for May 24, 2016, but the City of Austin has requested action on the resolution prior to May 20, 2016 to meet their submittal deadline. Discussion followed. Mr. Peña made a motion to approve the resolution. Ms. Sattler seconded the motion. Mr. Heath asked for an amendment to the include a request to the City of Austin to support the FM 685 superstreet concept. Mr. Peña indicated to add that to his motion. Ms. Sattler declined. The motion failed. Mr. Peña restated his initial motion to approve

the resolution. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

**11C.** <u>2016-4866</u>

Discuss and consider action regarding future agenda items.

Mr. Heath indicated that he had requested an item regarding the Goodman Corporation and it was stated that the item would be placed on the May 24, 2016 agenda.
