Regular Meeting

1. Call to order

Mayor Jeff Coleman called the regular meeting to order at 7:01 p.m. Councilmembers Wayne Cooper, Brad Marshall, Omar Peña and Starlet Sattler were in attendance. Councilmember Victor Gonzales was absent. City employees attending: Brandon Wade, City Manager, Raika Rowe, Assistant City Attorney; Karen Thompson, City Secretary, Lauri Gillam, Assistant City Manager; Trey Fletcher, Assistant City Manager; Tom Word, Assistant City Manager; Emily Barron, Planning Director; Dan Franz, City Engineer; James Hemenes, Parks Director; Terri Waggoner, Public Information Officer; Amy Good, Finance Director.

2. Opening

A. Pledge of Allegiance to the Flag of the United States of America: I pledge allegiance to the flag of the United States of America, and to the republic for which it stands: one nation under God, indivisible, with liberty and justice for all.

Mayor Coleman led those in attendance in reciting the Pledge of Allegiance to the Flag of the United States of America.

B. Pledge of Allegiance to the Texas State Flag: Honor the Texas flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible.

Mayor Coleman led those in attendance in reciting the Pledge of Allegiance to the Texas State Flag.

4A. ORD-0197

Hold a public hearing and consider approving an ordinance on first reading with the caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, ADOPTING THE FISCAL YEAR 2015 BUDGET FOR THE CITY OF PFLUGERVILLE, TEXAS.

There were no requests to speak at the public hearing. Mr. Cooper made a motion to close the public hearing. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

Ms. Sattler made a motion to approve the budget as presented. Mr. Cooper seconded the motion. All voted in favor. The motion carried.

5. Ordinance First Reading

5A. ORD-0198

Approving an ordinance on first reading with the caption reading: TAX LEVY ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS.

Mr. Marshall stated that he would like to lower the property tax rate to \$0.5340 or \$0.5336 to provide a 4-cent reduction. Discussion followed. Ms. Good and Ms. Gillam provided input. It was noted that appraisals increased this year and that \$0.5198 is the effective rate. Mr. Marshall made a motion that the property tax rate be increased by the adoption of a tax rate of \$0.5336, which is effectively a 2.7% increase in the tax rate. Mr. Cooper seconded the motion. Discussion followed. All voted in favor. The motion carried.

Mr. Marshall made a motion to approve a debt service tax rate of \$0.1636 per \$100 of valuation for the 2014 tax year. Ms. Sattler seconded the motion. Discussion followed. All voted in favor. The motion carried.

Mr. Marshall made a motion to approve a maintenance and operations tax rate of \$0.3700 per \$100 of valuation for the 2014 tax year. Mr. Cooper seconded the motion. All voted in favor. The motion carried.

Mr. Marshall made a motion to approve the Tax Levy Ordinance as amended. Mr. Cooper seconded the motion. All voted in favor. The motion carried.

6. Resolution

6A. RES-0202

Approving a resolution ratifying the property tax increase reflected in the City's fiscal year 2015 operating budget.

Mr. Peña made a motion to approve a resolution ratifying the property tax increase reflected in the City's fiscal year 2015 operating budget. He made a motion to approve the resolution as amended. Mr. Marshall seconded the motion. All voted in favor. The motion carried.
