**BACKGROUND/SUMMARY OF REQUEST:**

The City of Pflugerville is working with a landowner to annex a 4.724-acre tract of land that is currently in the city’s Extraterritorial Jurisdiction (ETJ). This tract is located at the intersection of Weiss Lane and Jesse Bohls Road. Weiss Lane is inside the city’s corporate city limits and is maintained by the city, while Jesse Bohls Road is in the ETJ and is currently maintained by Travis County. Pursuant to Section 43.106 of the Texas Local Government Code (TLGC), if a municipality wants to annex a tract of land, it also has to annex the full width of the adjacent right-of-way containing the county road. The TLGC goes on to stipulate in Section 43.1005 that if a municipality seeks to annex a roadway, the annexation must be authorized by the Commissioners Court. The City of Pflugerville is requesting that the Travis County Commissioners Court consent to their annexation of an approximately 281’ portion of Jesse Bohls Road starting at the Weiss Lane intersection. This portion of the roadway is further described in the attached field notes and is adjacent to the 4.724-acre tract of land that is being considered for annexation. Upon annexation, the city will be responsible for the maintenance of this portion of the roadway.

**STAFF RECOMMENDATIONS:**

TNR staff recommends that the Commissioners Court consent to the proposed annexation.

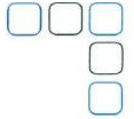

Dear Commissioners,

The City of Pflugerville has received a petition for annexation of approximately 4.724 acres of land situated in the Joseph Wiehl Survey No. 8, Abstract No. 802, in Travis County, Texas, of the real property records of Travis County, generally located along Weiss Lane at the intersection of Jesse Bohls Road within the City's extraterritorial jurisdiction. Please refer to the map on page 2.

Pursuant to Texas Local Government Code (TLGC) Section 43.106, a municipality that proposes to annex territory that abuts a county road must also annex the entire right-of-way containing the county road and related appurtenances. However, in order for the City to annex the portion of Jesse Bohls Road abutting the subject property petitioned for annexation, Travis County Commissioner's Court must authorize the City to annex the abutting roadway per TLGC Section 43.1055.

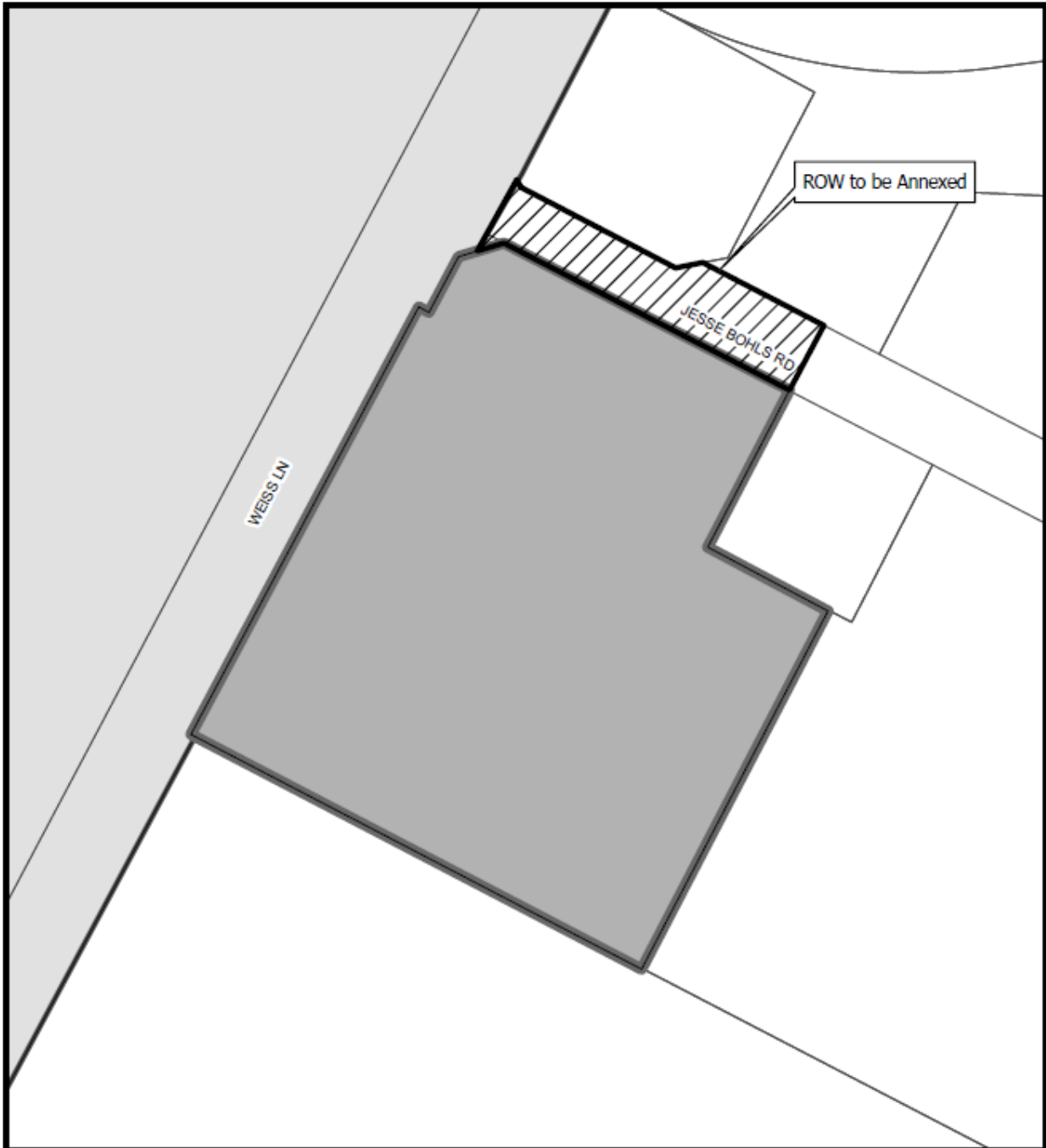
The City requests consent from Travis County to annex the portion of Jesse Bohls Road abutting the 4.7-acre tract of land as shown on the map and described in the attached field notes. With your consent, and upon final approval of the City of Pflugerville City Council, we will assume full maintenance responsibility of this portion of Jesse Bohls Road.

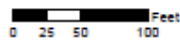


**17705 Weiss Lane

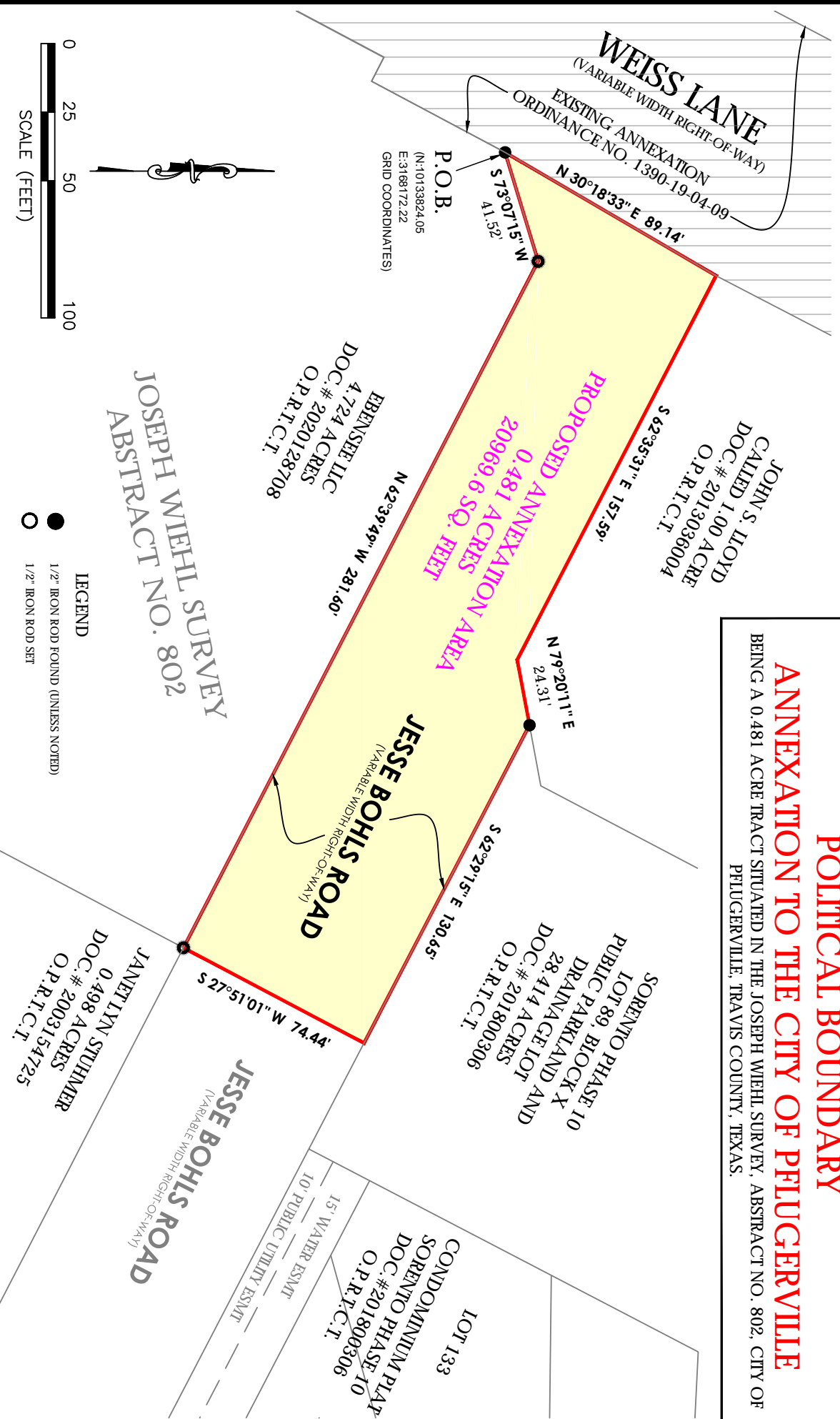
