AN ORDINANCE AMENDING CHAPTER 153 OF THE CODE OF ORDINANCES FOR THE CITY OF PFLUGERVILLE, TEXAS, BY AMENDING THE 2030 COMPREHENSIVE PLAN TO UPDATE THE ELEMENTS OF THE OVERALL PLAN AND ADOPT THE UPDATED TRANSPORTATION MASTER PLAN DATED NOVEMBER 2019 INCORPORATING AN UPDATED THOROUGHFARE PLAN MAP; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the vision for the City of Pflugerville, as defined by the 2030 Comprehensive Plan, is for Pflugerville to be the most desirable community in Central Texas because of its greatest assets such as first rate parks, connected trails, exceptional schools, cohesive neighborhoods, diverse and creative employment opportunities, and vibrant shopping districts; and

WHEREAS, the City of Pflugerville desires to adequately plan for transportation needs of the City as it continues to grow and expand; and

WHEREAS, a Transportation Master Plan is a long-range plan that identifies transportation objectives, solutions and policies for the growing transportation needs of the city; and

WHEREAS, the City Council approved the 2019 Transportation Master Plan on November 26, 2019; and

WHEREAS, the City Council of the City of Pflugerville has determined that it is necessary and beneficial to adopt policies and action items consistent with the recommendations and considerations of the 2019 Transportation Master Plan as provided in Exhibit A; and

WHEREAS, the approved 2019 Transportation Master Plan identified funding tools to be considered by the City for supporting transportation infrastructure; and

WHEREAS, the consultant, Kimley Horn and Associates was retained by the City of Pflugerville to prepare a Roadway Impact Fee Study and develop the update to the Transportation Master Plan; and

WHEREAS, the City Council desires to adopt the Roadway Impact Fees and align the related capital improvement plan approved on September 22, 2020 with the updated thoroughfare plan map provided in Exhibit B.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Section 1. The City hereby adopts the updated Transportation Master Plan as an element of the 2030 Comprehensive Plan.

Section 2. Chapter 153 Comprehensive Plan of the Code of Ordinances of the City of Pflugerville, Texas is hereby amended by adopting the 2019 Transportation Master Plan as provided in Exhibit A along with all recommended policies provided therein including recognition of the updated thoroughfare plan for the purposes of identifying future transportation needs, improvements and corridors.

Section 3. Effective Date.

This ordinance will take effect upon its passage by four affirmative votes on the first reading; provided that this Ordinance will be posted and adopted at a subsequent meeting in accordance with the provisions of Section 3.15(d) of the City Charter.

Section 4. Severability.

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.
