# **Outline**

The intent of this project is to remove paint, repair with historic wood and repaint with new roof the Pflugerville heritage house in accordance with all OSHA standards, applicable federal, state and local codes and regulation and good construction practices.

# KBR Scope of Work:

General:

- Supply supervision, quality inspections and project management required.
- Supply all equipment i.e. lifts scaffolds or ladders to safely complete the work.

# Lead Paint Abatement:

- File lead abatement forms with the State of Texas and monitor through completion.
- Remove all loose and flaky or delaminating paint to sound and tight condition.
- Existing paint will be feathered where loose paint has been removed.
- All debris will be removed by KBR. No bins, cans or PARKS carts will be used.
- Clean site of all debris, including removal and proper disposal.
- Supply the City of Pflugerville closing documentation of proper disposal of all abated material.

# Carpentry:

- After abatement is complete remove all rooted wood. 1X6 V groove cypress siding, 3ea. 5 ½" starting newels, 5ea. 9" round columns, various 20 ea. spindles and existing rotted screens.
- Supply and install heritage / vintage woods custom milled for the listed pieces above.
- Supply and install new custom milled porch decking to match existing for units that are rotted.
- Take full inventory and fabricate new screens as necessary for all windows. Supply matching screen brackets and aluminum screen material.
- Back prime and end prime all new wood replacement pieces.
- All debris will be removed by KBR. No bins, cans or PARKS carts will be used.
- Repair under pinning and seal off all areas.
- Clean site of all debris, including removal and proper disposal.

# KBR General Notes

- No Foundation work is part of this proposal.
- If bonding is required per law, bond costs have been included.
- All work shall be in accordance with all OSHA Standards, applicable federal, state, and local codes, and regulations and good construction practices.
- KBR will include all materials, equipment, and labor in the bid to complete the scope of work.
- KBR shall remove from site all spoils, equipment and materials after completion of this project.
- KBR is responsible for all measurements and quantities.
- Approval of this proposal designates acceptance of the scope of work statement and line item estimate which has been used only to develop a mutually agreed price. The price is accepted as a lump sum fixed firm price and the incorporated scope of work becomes the controlling document taking precedence over line item estimate detail.

# **KBR Exclusions**

- No Prevailing Wage included
- Hidden or unforeseen conditions.
- Removal or replacement of underground conduit or wires.
- Hazardous material handling or abatement.
- Removal or replacement of lighting control.
- Work on fire or security systems and sprinkler systems are not included in this proposal.
