#### **Regular Meeting**

## 1. Call to order

Mayor Jeff Coleman called the meeting to order at 7:05 p.m. Councilmembers Wayne Cooper, Brad Marshall and Starlet Sattler were in attendance. Councilmembers Darelle White and Victor Gonzales were absent. #### 5. Public Comment

Robert Spoonemore, 1005 Pecan Creek - Mr. Spoonemore commented on the length of time between when the new library was approved by voters and when construction will begin. He stated that he would like to see any extra bond money spent on books and furnishings and wants to be sure that all of the bond money goes to library needs and projects. He stated that he would like an off-leash dog park. He concluded by saying that he thinks that his taxes are a bargain, that he has no complaints and thinks that he is getting his money's worth.

Mr. Wade responded to Mr. Spoonemore's comments by assuring him that all of the money voted on to go to the library will go to the library. He informed Mr. Spoonemore that there is currently a dog park under construction at Murchison Ridge Trail.

Kim Waters, 17508 Kessler Dr. - Ms. Waters identified herself as a volunteer at the animal shelter and thanked everyone who participated in volunteer day at the animal shelter. She asked people to show up for the open house in support of the animal shelter which will be held October 22 from 10:00 a.m. to 12:00 p.m. She also commented that there will be animals available for adoption at the Chamber Expo on October 15.

Brent Hurta, 3104 Murrelet Way - Did not wish to speak but requested that the Mayor announce for the record his support for the addition of a skate spot or skate park facility to the park amenities in Pflugerville.

Hold a public hearing and consider an ordinance on first reading with the caption reading: AN ORDINANCE AMENDING THE CITY OF PFLUGERVILLE CODE OF ORDINANCES TITLE XV LAND USAGE, CHAPTER 157 UNIFIED DEVELOPMENT CODE AMENDING SUBCHAPTER 5 ESTABLISHMENT OF OVERLAYS AND SPECIAL DISTRICTS, SECTION (B) SH 130 AND SH 45 CORRIDOR DISTRICTS, TABLE 1: PERMITTED USES (WHOLESALE, MANUFACTURING AND INDUSTRIAL USES); REPLACING ALL ORDINANCES IN CONFLICT; CONTAINING A SAVINGS CLAUSE AND DECLARING AN EFFECTIVE DATE. (CA1109-01)

Hold a public hearing and consider an ordinance on first reading with the caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS AMENDING ORDINANCE NO. 874-07-04-10 OF THE CITY OF PFLUGERVILLE, TEXAS, AS AMENDED, BY APPROVING A SPECIAL DISTRICT FOR LIGHT INDUSTRIAL USES FOR APPROXIMATELY 15 ACRES OUT OF THE W. CALDWELL SURVEY NO. 66, ABSTRACT 162, PFLUGERVILLE, TX, GENERALLY LOCATED NEAR THE SOUTHWEST CORNER OF SH130 AND E. PECAN STREET, TO BE KNOWN AS THE PROJECT JERSEY SPECIAL DISTRICT (SD 1108-01), AND PROVIDING AN EFFECTIVE DATE.
