**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS  
SPECIFYING A PROPOSED FY21 TAX RATE AND  
SCHEDULING THE DATES FOR PUBLIC HEARINGS**

**WHEREAS**, the governing body of Pflugerville previously, at a properly convened meeting, authorized and directed the Finance Director or her successor of the City of Pflugerville to notify the Travis County Tax Assessor-Collector to calculate the voter-approval tax rate of the City of Pflugerville using the special taxing unit cap rate of 8% pursuant to Texas Tax Code §26.04(c-1) as a result of the Declaration of Disaster issued by the President of the United States and the Texas Governor; and

**WHEREAS**, the City Council finds the City of Pflugerville's proposed FY21 budget specifies a tax rate that does not exceed the voter approval rate (\$0.4998), but does exceed the no new revenue rate (\$0.4945); and

**WHEREAS**, the City Council finds the Texas Property Tax Code requires certain action when the proposed fiscal year property tax rate exceeds either the voter approval rate or the no new revenue tax rate, whichever is lower.

**NOW THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

- 1) That the proposed tax rate for FY21 is \$ 0.4970.
- 2) **THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**
- 3) **THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7% AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$13.20.**
- 4) The roll call vote on this Resolution is recorded as follows:
