**A RESOLUTION OF THE CITY OF PFLUGERVILLE CHANGING THE  
CITY OF PFLUGERVILLE REPRESENTATION ON THE CAPITAL  
AREA METROPOLITAN PLANNING ORGANIZATION  
TRANSPORTATION POLICY BOARD**

WHEREAS, the City of Pflugerville desires to participate and engage in policy level transportation issues affecting the Pflugerville and the Central Texas region; and

WHEREAS, in 2010, the CAMPO Transportation Policy Board acted to include Pflugerville on the Transportation Policy Board and the City Council took action on March 23, 2010 to accept the position and to appoint Mayor Jeff Coleman to serve as the City of Pflugerville representative and specified that any Councilmember could serve as the alternate member; and

WHEREAS, the City Council took action on June 28, 2011 to change representation and appointed Victor Gonzales to serve as the City of Pflugerville representative and specified that any Councilmember could serve as the alternate member; and

WHEREAS, the City Council took action on November 26, 2013 to change representation and appointed Mayor Jeff Coleman to serve as the City of Pflugerville representative and specified that any Councilmember could serve as the alternate member; and

WHEREAS, the City Council took action on November 22, 2016 to change representation and appointed Mayor Elect Victor Gonzales to serve as the City of Pflugerville representative and specified that any Councilmember could serve as the alternate member; and

WHEREAS, the City Council took action on June 27, 2017 to change representation and appointed Mayor Pro Tem Omar Peña to serve as the City of Pflugerville representative and specified that any Councilmember or the Mayor could serve as the alternate member; and

WHEREAS, the City Council took action on November 27, 2018 to change representation and appointed Mayor Victor Gonzales to serve as the City of Pflugerville representative and that Councilmember Rudy Metayer was the designated alternate and that any Councilmember may serve as alternate; and

WHEREAS, the City Council took action on November 26, 2019 to change representation and appointed Councilmember Rudy Metayer to serve as the City of Pflugerville representative and that Mayor Gonzales was the designated alternate and that any Councilmember may serve as alternate; and

WHEREAS, the City Council took action on November 24, 2020 and appointed Councilmember Rudy Metayer to serve as the City of Pflugerville representative and that Mayor Gonzales was the designated alternate and that any Councilmember may serve as alternate; and

WHEREAS, the City Council took action on November 30, 2021 and appointed Councilmember Rudy Metayer to serve as the City of Pflugerville representative and that Mayor Gonzales was the designated alternate and that any Councilmember may serve as alternate; and

WHEREAS, the City Council now deems it appropriate to change its representation on the Capital Metropolitan Planning Organization Transportation Policy Board.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pflugerville that:
