Mayor Victor Gonzales called the worksession to order at 5:35 p.m. The worksession was held by telephone/video conference. Councilmembers Doug Weiss, Ceasar Ruiz, and Mike Heath were in attendance. [2021-0391](#) Discuss the Statement of Services and Revised Statement of Services approved by the Travis County Emergency Services District (ESD) No. 2 Board of Commissioners and related implications regarding the provision of first response, emergency medical services and pre-hospital treatment in the City of Pflugerville and the City of Pflugerville Extraterritorial Jurisdiction (ETJ) on short and long term basis.

Mr. Weiss reported that he had attended the ESD2 Board meeting on April 19, 2021 and the ESD2 provided clarification that they will continue to provide emergency medical services through the end of their fiscal year, firefighters will provide first responder services indefinitely and they will work with the City on the transition of service to ensure service is provided to citizens without a gap. Council discussion followed with input from Mr. Zech. Mr. Weiss stated that he is satisfied at this point in time and Mr. Metayer stated to agree. Mayor Pro Tem Peña provided comments on moving quickly and through the process correctly.
