Discuss Pflugerville ISD Enrollment and Facility Trends and Projections.

Trey Fletcher presented the PISD Planning Data for the 2011 2012 Enrollment.

Enrollment in September is 22,982 students for the September 2011 school year that is 1.5% increase in the past year. The school district has increase by approximately 15,000 students in the past 10 years.

The future Build out estimate for PISD is for 50,000 student enrollment, 33 elementary schools, 12 middle school and 5 high schools. The PISD schools opened to date are 18 primary/elementary schools, 5 middle schools, 4 high school/alternate schools and 2 administration facilities.

The undeveloped properties owned by PISD are located at: Pecan St. /Swenson Farms Blvd., Andrewartha (Killingsworth Ln.), Black Locust, New Sweden and Fuchs (Jesse Bohls/Cameron/Cele Rd.)

PISD is using 2007 Bonds to fund these facilities: elementary #19 at the end of Harris Ridge Dr, scheduled to open in the 2012 2013 school year; elementary #20 (location unknown), scheduled to open in the 2014 2015 school year; and middle school #6 on Cele Rd. east of Hodde Lane, scheduled to be open in the 2013 2014 school year.

Mr. Randy Wilbanks with the PISD, added that as of the end of today, October 3, 2011, PISD have 23,005 students enrolled.

Trey Fletcher opened this item noting that the City of Pflugerville has entered into a lease agreement with the Travis County ESD #2 for approximately 6,000 sq. ft. on the first floor of the Conference and Education Center at 201B East Pecan Street, starting October 1, 2011. The purpose of lease and the space is to accommodate the Building, Planning, GIS and Engineering Department to form the Development Services Center.

Mr. Fletcher presented a PowerPoint presentation with the schematic of the view of the existing site as it is now and the future look of the Development

Services Center once the construction is done.
