**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS AUTHORIZING AN INTERLOCAL COOPERATION AGREEMENT WITH TRAVIS COUNTY REGARDING THE PLACEMENT OF A PIPE ENCASUREMENT FOR THE CITY'S SECONDARY COLORADO RIVER RAW WATER LINE ALONG WELLS BRANCH PARKWAY**

**WHEREAS**, The Interlocal Cooperation Act, Chapter 791 of the Texas Government Code, authorizes governmental entities to contract with each other to perform governmental functions and services under the terms thereof; and

**WHEREAS**, The City of Pflugerville and Travis County are political subdivisions within the State of Texas and engaged in the provision of governmental services for the benefit of their citizens; and

**WHEREAS**, The City and the County desire to establish and define the roles entered into in relation to the design, construction, of the required relocation of the existing raw waterline and valve installation with installation of new steel casing for the proposed Secondary Colorado River Raw waterline and

**WHEREAS**, The County's new Wells Branch Parkway improvements require relocation of the City of Pflugerville's existing 30-inch raw waterline and

**WHEREAS**, The City of Pflugerville and Travis County entered into an Interlocal Cooperation Agreement ("Agreement") in order to cooperate planning, design, and construction of improvements.

**WHEREAS**, The Project includes the county relocating the City of Pflugerville's existing 30-inch waterline with steel encasement and install a new 30-inch gate valve for the existing waterline, and install 431 linear feet of new 66-inch steel encasement for the Secondary Colorado River waterline and

**WHEREAS**, The City of Pflugerville will compensate the Travis County only for the costs of the new 30-inch gate valve and 431 linear feet of new 66-inch steel encasement at the bid item unit price identified in the Contractor's Wells Branch Parkway Improvements contract as awarded by Travis County.

**WHEREAS**, The Parties intend to conform this Agreement in all respects to the Interlocal Cooperation Act, Texas Government Code Section 791.001 et seq.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

1. The above recitals are hereby found to be true and correct by the City Council of the City of Pflugerville and incorporated herein for all purposes.
2. That the City Council authorize the City Manager to execute the Interlocal Cooperation Agreement with Travis County, attached hereto as Exhibit "A".
