#### Regular Meeting

Aaron Millis reported that the Friends raised about \$1500 from their April book sale and signed up 26 new members. The annual meeting is April 21st and will include teen volunteer awards and commemorating Audrey T. Dearing with a dedication of the wing of the library now named in her honor.

- Marketing and Outreach Coordinator Tiara Allen reported it has been a great month for outreach, including multiple school visits. She discussed the mascot idea further with the city's Communications Department and they like the idea of holding a design contest. This idea still needs to be discussed with the city's legal department.

- Director Griswold reported the Board survey will be closing soon and she will bring the results next month. Stats are very close to last year's numbers so far. Program highlights from last month include: a Mini Horses Story Time, a Story Time performance by Ramblin' Rita, a Writer's League of Texas led Craft and Business of Writing Workshop, Teen Job Fair and Pet Pfest. Upcoming programs include Homeschool Pfair, Water Conservation for Families and our Literary Costume Ball.

- Chair Robertson reported that Kimberlee Reist from the Friends discussed the summit idea with the Georgetown Library's Friends of the Library group. The Board discussed possible dates for the first summit and decided on this August as their goal.

- Director Griswold reported that City Administration is not in favor of eliminating non-resident fees at this time. She also shared some related stats including: 2.5 % of card holders are non-residents, the library currently has between 30 and 31 thousand active members, and non-resident cards account for about \$18,000 in annual revenue.

- Director Griswold reported that the policy committee met to review the policies and added comments. Suggested edits were reviewed by the board. The policies will be brought back next month to give everyone additional time to review.
