#### 1. Call to Order

Parks and Recreation Director Jim Bowlin called the meeting to order at 7:06 p.m. Commissioners present: Edward Marburger, Raul Capetillo, Glenn Beck, Melody Ryan, Christie Crouch, Sarah Young and Dave Taylor. Commissioner Nicole Ward arrived shortly after the Call to Order. Staff present: Tom Word, Assistant City Manager for Community Services; Jim Bowlin, Parks and Recreation Director; Sheila Wiora, Assistant Parks & Recreation Director; Jacquelyn Smith, Administrative Assistant; and Terri Waggoner, Public Information Officer.

Items were addressed in the order as recorded in the minutes.

Mr. Bowlin asked for each commissioner to give a little background about themselves and then each was given the opportunity to introduce him or herself to the other commissioners.

Commissioner Crouch suggested that introductions be made and any supplemental information that nominees might have would be handed out. Mr. Bowlin then asked the Commissioners

to introduce themselves.

After introductions, Commissioner Beck removed himself from consideration for Chair of the Commission. A vote of the Commission was taken and Commissioners Crouch, Beck, Capetillo and Marburger voted for Ms. Crouch. Commissioners Young, Ward and Ryan voted for Ms. Ryan. Commissioner Crouch was elected as Chair.

Mr. Bowlin then asked the Commission to defer the rest of the voting until Ms. Terri Waggoner had finished her presentation for Item 5B.

## 5. Discuss Only

#### 5A. 2013-1617

Parks and Recreation Director's updates regarding Legistar agenda management system, volunteer efforts, Pfreeze Pflop, Walker's Club and Winter Pfun Camp.

Parks and Recreation Director Jim Bowlin presented this item.

Mr. Bowlin discussed the status of current projects and activities within the Parks and Recreation Department including:

- Legistar Agenda Management System Mr. Bowlin announced to the Commissioners that we will be using a new tool for managing agendas and everything may look a little different when viewing Commission packet materials. Mr. Bowlin explained how to navigate to agenda items.
- Volunteer Efforts Mr. Bowlin reported to the Commission that staff have started capturing the total number of volunteer hours being logged in the City

and since August 2012, volunteers have logged 2,671 hours of volunteering.

- Pfreeze Pflop Mr. Bowlin indicated that the annual Pfreeze Pflop was held on January 1, 2013 at Mentzer Park. Sixty-five (65) people braved the gusty 40 degree wintry weather to ride down the slide into 44 degree water and 100 pounds of canned food was donated to the Storehouse Food Bank.
- Walker's Club Mr. Bowlin said that the 8th Annual Walkers Club Program luncheon was held in December recognizing the top walkers from the club's 145 participants. Out of the 145 participants, 23 persons walked 500 miles or more with 4 persons having walked over 1,000 miles.
- Winter Pfun Camp Mr. Bowlin stated that Winter Holiday Pfun Camp was offered at the Recreation Center for eight days in December and ninety-seven children participated. Pfun activities included: making gingerbread houses and rice crispy treats as well as crafts and playing games at the Recreation Center. There were field trips and excursions to Bohl's and Pfluger parks, the library, Georgetown bowling lanes, the "Play for all Abilities" playground, Zilker Park and the movies.

Discuss and consider action to approve the minutes of the December 20, 2012 Parks and Recreation Commission meeting.

Commissioner Ryan motioned to approve the minutes and Commissioner Beck seconded the motion. Motion was unanimous.

Future agenda items included: the Deutschen Pfest project; approved General Capital Reserve items; and Parkland Dedication Ordinance.
