I submit this engagement letter to the City to provide Special Counsel’s services to the City involving support and representation related to the Water Master Plan, Water Modeling and Water Supply issues affecting the city.

I, George E. Hyde, will be the supervising partner and your primary contact for this engagement. Associates Ross Fischer and Erin A. Higginbotham will assist when necessary on this matter. Depending on your need and work load, other lawyers in the firm may be used when necessary to increase our ability to respond to your needs and reduce your overall costs in connection with our engagement when appropriate.

Denton, Navarro, Rocha & Bernal, P.C. has found that the practice of billing clients on an hourly basis, for work actually completed, and with invoices submitted on a monthly basis works best for our clients and us. Our invoices are due on receipt and are past due after thirty days. Our hourly billing rates for our engagement with the City are as follows: \$195 per hour for Partners; \$175 per hour for Associate Attorneys; \$125 per hour for Law Clerks; and \$85 per hour for Paralegals.
