Update from Austin Public Health regarding COVID-19 conditions.

Mayor Gonzales opened the item for discussion. Dr. Desmar Walkes, Medical Director, and Adrienne Stirrup, Interim Director were present from Austin Public Health. Dr. Walkes provided an update stating Austin Public Health has moved to Stage 5 and provided information about what that entailed for vaccinated and unvaccinated individuals. Dr. Walkes provided data about what has happened through the pandemic so far including case number details and information about the variants. Dr. Walkes and Ms. Stirrup answered questions from council about the case numbers, variants, and the current situation in Pflugerville.
