MEMORANDUM OF UNDERSTANDING TEXAS DEPARTMENT OF TRANSPORTATION – AUSTIN DISTRICT THE CITY OF PFLUGERVILLE

This Memorandum of Understanding ("MOU") is entered into by and between Texas Department of Transportation ("TXDOT"), a transportation authority for the State of Texas and the City of Pflugerville ("City"), a Texas municipal corporation and political subdivision of the State of Texas. TXDOT and the City are referred to in this Agreement collectively as the "Parties" and individually as a "Party".

The Parties hereto have agreed to the mutual obligations and performance of the conditions of this Agreement as hereinafter described.

WHEREAS, TxDOT will enter into this Memorandum of Understanding (MOU) with the City of Pflugarville for intersection improvements to allow for increased safety and/or improved congestion on the intersections of E. Pflugerville Parkway / FM685 and Copper Mine / FM685 / SH130.

WHEREAS, the Parties understand and agree future intersection improvements which are to be mutually agreed upon by the Parties are contingent on pursuing a Local On-System Agreement (LOSA) with the intent of the City of Pflugerville to fund and construct the agreed upon improvements at these intersections and is subject to the approval of the Texas Transportation Commission.

Through this MOU, TxDOT implements its authority under Texas Transportation Code §201.103, which authorizes TxDOT to plan and make policies for the location, construction, and maintenance of a comprehensive system of state highways and public roads.

Texas Transportation Code, §201.206, authorizes TxDOT to accept, from any source, a donation or contribution in any form, including realty, money, materials, or services, for the purpose of carrying out its functions and duties.
