1. Call to Order

Chair Trevino called the regular meeting to order at 7:04pm.

Discuss and consider action regarding the City of Pflugerville's Mobility Master Plan.

Kelly Rees from Kimley-Horn presented to the commission an overview regarding the City of Pflugerville's Mobility Master Plan (MMP). She gave information regarding how the master plan was developed, what the MMP is, and the vision of the plan. She also went over the trail plans, including off street trails and on street trails, the original and updated trail plans, tying in trail connection points from both Austin and Round Rock, items that were changed since previously meeting at the March PARC Commission meeting, and the remaining Mobility Master Plan Schedule.

Commissioner Taylor made the motion to approve the Mobility Master Plan. Commissioner Call seconded the motion. All voted in favor and the motion passed.
