AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES, CHAPTER 72 REGARDING SPEED LIMITS ON CITY STREETS (KELLY LANE), ESTABLISHING PRIMA FACIE MAXIMUM SPEEDS, AND PROVIDING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Section 1. Chapter 72, Schedule II of the City of Pflugerville, Texas Code of Ordinances is hereby amended by replacing the current speed limits with the following speed limits for the corresponding street sections.

SCHEDULE II. SPEED LIMITS ON CITY STREETS

The prima facie maximum speed limits for the section of the streets described below are as follows:

<i>Street</i>	<i>Direction of Traffic</i>	<i>Location</i>	<i>Speed Limit (m.p.h.)</i>
Kelly Ln	eastbound and westbound	Beginning at SH 130 Frontage Rd intersection and ending at Falcon Pointe Blvd/ Vilamoura St intersection.	40
Kelly Ln	eastbound and westbound	Beginning at Falcon Pointe Blvd/Vilamoura St intersection and ending at Weiss Ln	45
Kelly Ln	eastbound and westbound	Beginning at 159 ft west of Benning Dr intersection and ending 219 ft. east of Kennemer Dr intersection.	25 mph when school speed zone device flashing

Section 2. Severability.

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

Section 3. Repealer.

This ordinance shall be cumulative of all other ordinances of the City of Pflugerville, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Pflugerville except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

Section 3. Effective Date.

This Ordinance will take effect upon its adoption by the City Council and publication of the caption hereof in accordance with Section 3.15(d) of the City Charter.
