#### 1. Call to order

Mayor Victor Gonzales called the worksession to order at 7:00pm Mayor Pro Tem Omar Peña, Councilmembers Doug Weiss, David Rogers, Mike Heath, Rudy Metayer, and Ceasar Ruiz were in attendance.

Mayor Gonzales observed a moment of silence.

#### 3. Items of Community Interest

Mayor Gonzales stated the Blue Santa program provides assistance with gifts and food to families in need during the holiday season and the 2021

application is now open and accepting donations.

Mayor Gonzales stated November is adopt a senior pet month at Pflugerville Animal Welfare Services with fees waived for adoptions on senior pets.

Mayor Gonzales stated the Pfall Pfun Pfestival is Saturday, November 13 from 9am-4pm at Typhoon Texas Waterpark.

Mayor Gonzales stated the Pfestive Pfarmers Market is underway today, November 23, December 7 and 14th from 3-7pm.

Mayor Gonzales stated there is a walk-up vaccine clinic on Wednesdays from 2-7pm at the Pflugerville Library through partnership with Austin Public Health.

Mr. Rogers congratulated Kimberly Holiday and Jim McDonald.

Mr. Rogers congratulated those involved for putting together the University of Austin

Mr. Rogers thanked everyone on the dais and all of the citizens on both sides of the discussion regarding the ESD. He stated everyone on both sides did a great job and was heartened by the thoughtful, educated, and passionate response.

Mr. Heath stated that with the changing weather it is a good time to remind people to sign up for Warn Central Texas for weather notifications and to visit with your neighbor to make sure you know them.

#### 4. Presentation

**4B.** 2021-1162 Mayor's Proclamation declaring November 9, 2021 as John Brotherton day in the City of Pflugerville.

Mayor Gonzales read the proclamation proclaiming November 9, 2021 as John Brotherton day in the City of Pflugerville and thanked Mr. Brotherton for his service to the community. Mr. Brotherton stated that while he dreamed of owning is own BBQ joint, he really dreamed of being able to give back to the community.

**4A.** 2021-1193

Presentation of appreciation to Mr. Omar Peña for service to the City as City Councilmember Place 3 from November 2012 to November 2021 and Mayor Pro Tem from 2016 to 2021, and Mr. Mike Heath for service to the City as City Councilmember Place 5 from November 2015 to November 2021.

Mayor Gonzales presented a proclamation to Mayor Pro Tem Peña recognizing his service to the City Council for the past nine years and presented him with a gift. Mayor Pro Tem Peña thanked his wife for her help along the way and spoke about his experience on the council. He challenged those who remain on council and those who are coming on the council to continue the work.

Mayor Gonzales presented a proclamation to Mr. Heath recognizing his service to the City Council for the past six years and presented him with a gift. Mr. Heath thanked his wife, family and friends. He stated it has been a pleasure to work with the fellow council members who have dedicated themselves to the community. He encouraged council to continue moving forward and hold each other accountable.

**4C.** 2021-1169 Presentation regarding status of the Aspire 2040 Comprehensive Plan

and Unified Development Code (UDC) Updates.

Mayor Gonzales opened the item for discussion. Ms. Barron gave a presentation about the Aspire 2040 Comprehensive Plan. She thanked the communications department for their help in ensuring public engagement even through a pandemic. Ms. Barron provided information on the Preparation of Plan Chapters and stated that following the anticipated adoption of the plan it would move to Unified Development Code amendment review. Ms. Barron provided a brief overview of the UDC amendment process.

### 5. Public Comment

Cliff Avery stated he accepts the outcome of the election even if he wishes it went the other way. He stated it is up to council to figure out what exactly the people said. He stated he does not believe the voters were endorsing a for profit ambulance service as they also elected two council members who spoke against for profit ambulance service. Mr. Avery stated it is now up to council and the board to interpret the message and stated they should renew talks.

Terry Newsom thanked council for standing firm on the ESD matter. He stated the people have spoken and it was not by a small margin. He stated Pflugerville has overwhelmingly voted and now the ESD is voicing interest in communicating. Mr. Newsom asked council to approve the Acadian contract and give the people who were willing to work with city council the chance.

Anthony Nguyen stated that after the election the council now has to make a decision before the end of the year since the ESD has stated they will not provide it. Mr. Nguyen stated he understands the council may have offered an olive branch but there is no time to delay and usually no decision is a wrong decision. He stated he would like council to do something tonight and he would not urge a direction but a decision.

Melody Ryan thanked council for protecting the citizens over the past few months. She stated the people have spoken and rejected the tax and are supporting the city council's plan as they knew what the council was planning to do when they voted. Ms. Ryan stated the action was delayed until after the election and not people have spoken. Ms. Ryan urged council to have a seal at the table for discussions regarding future expansion plans.

Jim McDonald stated that last Saturday council delayed the vote on the contract until after the election. He stated the results have been heard and citizens do not want the overlay. Mr. McDonald stated he disagrees that means they are in favor of privatizing the EMS service. He stated with the changing council there may be a way toward partnering with ESD2 as previously mentioned by AP Triton and asked council to consider delaying the vote until November 30th.

#### Reading of the Consent Agenda

Mayor Gonzales opened the item for discussion. Ms. Davis provided an overview of the project stating TxDOT has already given authorization. Mr. Metayer stated this project shows good foresight and work from staff. Mr. Weiss stated he is excited to see this moving forward. Mr. Heath made a motion to approve the resolution. Mr. Metayer seconded the motion. All voted in favor.

#### Other Actions - Removed from the Consent Agenda

**10E**. 2021-1172

Approving Amendment 1 to Capital Area Emergency Communications District Interlocal Contract for Public Safety Answering Point Maintenance, Equipment and Training and authorizing the City Manager to execute same.

Mayor Gonzales opened the item for discussion. Mr. Heath stated he wanted to point out how important Public Safety Answering Point (PSAP) is with coordination on a regional basis. Billy Gibbens, Civilian Commander, provided information about the item stating with the additional console the city will be

receiving an additional \$500 which will be added to the budget for operational needs. Mr. Heath made a motion to approve the item. Mayor Pro Tem Peña seconded the motion. All voted in favor.

#### 11. Discuss and Consider Action

**11A.** 2021-1173

Discuss and consider action to award a construction contract for the Grand Avenue Reconstruction Project to Terra Path, Inc. the lowest responsible bidder of six (6) accepted bids received on October 21, 2021, in the amount of \$2,756,000 and authorizing the City Manager to execute same.

Mayor Gonzales opened the item for discussion. Ms. Davis gave a presentation regarding the Grand Avenue Reconstruction Project. She stated the Traffic Control Plan has been coordinated and approved by multiple entities. Ms. Davis answered questions from the council regarding the process. Mr. Rogers asked how fast the project can be completed. Ms. Davis stated staff is working with the contractor to move this as fast as possible and the contractor is motivated and willing to move this project along. Ms. Davis stated the contract time is 150 days for substantial completion and 180 days for full completion. Mr. Metayer stated this was not an anticipated issue and staff worked deliberately to find the right people with the right plan. Mr. Metayer made a motion to approve the item. Mr. Rogers seconded the motion. All voted in favor.

**11B.** <u>2021-1132</u>

Discuss and consider action approving a contract with Acadian Ambulance Services for EMS services in the City and extraterritorial jurisdiction (ETJ) and authorizing the City Manager to execute same.

Mayor Gonzales read the item. Mr. Metayer requested council retire to executive session for discussion with legal council. Mayor Gonzales announced council was retiring to executive session at 7:56pm. Mayor Gonzales reconvened the meeting in open session at 9:29pm.

Mr. Zech stated all the contractual items that were raised as possible issues have been satisfied and the representative from Acadian has indicated they are comfortable with the changes. Mr. Weiss made a motion to approve the contract as amended and authorize the city manager to execute the agreement. Mayor Pro Tem Peña requested an amended to have the contract fully executed by close of business on November 11. Mr. Weiss accepted the amendment. Mr. Rogers seconded the motion as amended. The vote was as follows: Mr. Weiss – yes, Mr. Ruiz – no, Mayor Pro Tem Peña – yes, Mr. Metayer – no, Mr. Rogers – yes, Mr. Heath – yes, Mayor Gonzales – yes. The motion carried.
