Discussion regarding the Pflugerville Community Development Corporation's Executive Directors goals and priorities.

Mr. Jones provided a detailed draft document outlining the Executive Director's priorities and goals for PCDC.

To recap, Mr. Jones shared the following goals:

- Retail Development – To enhance retail recruitment and retention efforts.
- Parks and Mixed-Use Development – Continue to commit to supporting parks through our annual \$300,000 financial support and identify ways to encourage mixed-use developments to enhance economic activity and quality of life through possible infrastructure incentive agreements.

The board confirmed continuing to use community engagement projects to request funds for parks, public infrastructure, and requests from other organizations.

- Branding and Marketing – Create a unique brand and marketing campaign that showcases Pflugerville's strengths, diversity, and inclusivity from an Economic Development perspective.
- Development Processes – To ensure Pflugerville's development processes and fees are competitive.
- Business Attraction and Expansion – To pursue relocation and expansion projects and strategically acquire land for development.
