#### Regular Meeting

#### 1. Call to Order

Mayor Victor Gonzales called the regular meeting to order at 7:00pm. Mayor Pro Tem Doug Weiss and Councilmembers Ceasar Ruiz, Kimberly Holiday, Rudy Metayer, Jim McDonald, and David Rogers were in attendance.

Mayor Gonzales opened the item. Mr. Groeschel reviewed public works operations including the pavement maintenance program, drainage, and facility maintenance. Mr. Rogers asked about anticipated staffing needs with a new city hall. Mr. Groeschel discussed plans to accommodate. Ms. Morrison provided information about public works administrative report, capital services, and real estate management. Ms. Miga reviewed development engineering including reviews conducted and construction inspection. Mr. Chacon discussed disaster preparedness and planning and answered questions from council. Mr. Chacon provided information about special event planning. Mayor Pro Tem Weiss asked about volunteers during an emergency. Mr. Chacon provided information. Mr. Pritchett reviewed water and wastewater operations including the AMI monitoring system and maintenance for the systems.

## **6. Regular Agenda**

- 6A.**     [2024-0454](#)     Conduct introductions and take action to make appointments to the Deutschen Pfest Committee.

**Mayor Gonzales opened the item for discussion. Susan Meyer introduced**

herself and discussed her history with the city. Ms. Meyer answered questions from council. Mr. Metayer moved to appoint Susan Meyer to the Deutschen Pfest Committee. Mayor Pro Tem Weiss seconded the motion. All voted in favor. The motion carried.

**6B.**     [2024-0421](#)

Discussion regarding a contract for Advanced Life Support EMS Services within the City of Pflugerville.

Mayor Gonzales opened the item for discussion. Nick Perkins, Travis County ESD2 Chief, reviewed the proposed ambulance service to include four ambulances, stations, and the ability to have up to eight ambulances during emergencies. Chief Perkins stated the cost is \$2 million annually with the option to offset cost by using billing revenue from inter facility transfers. Chief Perkins reviewed the training and answered questions from council regarding licensing. Chief Perkins stated there is a supervisor at every incident and discussed quality management staff. Mr. Chacon stated they have been discussing a longer agreement term for four years with two one year options to add on.

Daniel Gillespie with Allegiance Mobile Health reviewed the current agreement discussed the increased hospital use. Mr. Gillespie provided information about Allegiance and discussed ensuring resources provided match the needs. Mr. Gillespie provided an operational review including responses, transports, and response times. Mr. Gillespie discussed how the funds would be used. Mr. Rogers asked where most patients are going. Discussion followed regarding transport locations and cost of transport. Mr. Ruiz asked about patient transport requests. Mayor Pro Tem Weiss asked about insurances in network.

Mayor Gonzales discussed the importance of quality of care on calls and asked Mr. Gillespie about training. Mr. Gillespie reviewed Allegiance's training and continuing education. Ms. Holiday asked about the working relationship between Allegiance and Travis County ESD2 and the cost and term limits. Mr. Gillespie stated the price is \$1.9 million for five ambulances, \$1.3 for four, and stated everyone is there to take care of the patient. Discussion followed regarding the proposal and cost of service.

Mr. Chacon discussed building out more performance metrics and reviewed the options. Mayor Gonzales discussed quality of care. Ms. Holiday asked if ESD2 would be willing to do it for \$1.3 million. Chief Perkins stated he was not present to negotiate. Discussion followed regarding next steps at the May 28 council meeting.

**6C.**     [RES-1212](#)

Discuss and consider action to approve a resolution of the City Council of the City of Pflugerville, Texas, directing the City Manager or the City Manager's designee to execute all documents to institute eminent domain proceedings for the acquisition of land situated for right of way in Pflugerville, Travis County, Texas and directing the City Attorney to initiate condemnation proceedings associated with the East Pflugerville Parkway Roadway Expansion Project.

Mayor Gonzales opened the item for discussion. Ms. Morrison reviewed the project and stated the owners of the location suggested eminent domain due to the property owner bylaw requirements. Mayor Pro Tem Weiss moved to

approve the item. Mr. Metayer seconded the motion. All voted in favor. The motion carried.

**6D. [2024-0461](#)**

Discuss and consider action on a fiber infrastructure provider.

Mayor Gonzales opened the item for discussion. Mr. Hunter reviewed the history of discussions with Google Fiber and discussed making requests for engineering estimates and red-lined agreements without receiving them. Mr. Hunter answered questions from council regarding the communications and discussion followed. Mr. Ruiz discussed hearing concerns from the ISD about areas in the city that do not have good service.

John Michael Cortez with Google discussed remaining interested in Pflugerville but have not been able to get aligned with deployment. Mr. Cortez stated concern has been expressed about damage to the infrastructure and discussed the timeline. Mr. Cortez answered questions from council regarding coordinating with other cities and micro trenching. Mr. Hunter discussed other providers that have stated they would not need to micro trench. Mayor Pro Tem Weiss asked about a red-line agreement from Google. Mr. Cortez discussed areas where they are far apart from consensus. Ms. Breland provided information about the City's coordination on an agreement. Discussion followed regarding the current state of an agreement. Mr. Hunter discussed other providers that have approached the city. Mayor Gonzales reviewed the discussion to reach out the ISD to identify demands and can come back with information on the areas in need to build into an RFP or RFQ.

Discussion regarding the 5-year Capital Improvement Plan for FY 2025-2029 related to drainage, information technology, facilities, parks, transportation, reclaimed water, water, and wastewater projects.

Mayor Gonzales opened the item for discussion. Mr. Metayer stated it is great to see the program provide people with career opportunities and it shows forward thinking with government working together. Mr. Rogers moved to approve the item. Mayor Pro Tem Weiss seconded the motion. Mr. McDonald was not present for the vote. All others voted in favor. The motion carried.

Approving the purchase and installation of an Ultra-Violet (UV)

sanitization system from Progressive Commercial Aquatics, Inc. at Scott Mentzer Pool, located at 901 Old Austin Hutto Road, in the amount of \$50,907.69, and authorizing the City Manager to execute the same.

Mayor Gonzales opened the item for discussion. Mr. Mize provided information about the UV sanitation system and how it works. Mr. Mize discussed the CDC update and their recommendation of UV systems for all facilities. Ms. Holiday moved to approve the item. Mayor Pro Tem Weiss seconded the motion. All voted in favor. The motion carried.
