**VACATION, ABANDONMENT AND RELEASE OF TEMPORARY DRAINAGE
EASEMENT**

WHEREAS, by that certain instrument dated June 14, 2024, recorded as Document No. 2024065731 of the Real Property Records of Travis County, a temporary drainage easement on Lot 1 & 3 was granted to the City of Pflugerville, Texas ("City") described as an 4.473 acre tract situated in Travis County, Texas ("Property"), being more particularly described in Exhibit "A", attached hereto and incorporated herein for all purposes; and

WHEREAS, the owners of the underlying land have requested that the City vacate, abandon, and release temporary drainage easement on Lot 1 & 3 only that are no longer needed for construction of Colorado Sand Drive Project from Copper Mine southward to the connection point with existing Colorado Sand Drive near Lone Star Ranch Boulevard; and

WHEREAS the City has no further need for the temporary drainage easement on Lot 1 & 3 - for this roadway project, and the temporary drainage easement on Lot 4 will remain.

NOW THEREFORE, for ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City does hereby for all purposes: (i) VACATE, ABANDON, AND RELEASE the easement described in Exhibit A (Lot 1 & 3), which is attached hereto and incorporated herein; and (ii) relinquish all of its rights, title and interest in and to the Easement. It is expressly agreed and understood that this is a release of only said Easement and that this release does not release, affect or impair any other remaining easements as they may relate to the Property or any real property which is not included within the Property.
