Overall Recommendation of Award

WCRWWTF Phase 1 Construction - Guaranteed Maximum Price No. 2 (GMP2) - Balance of Plant

## Dear Mr. Dunsworth:

This memorandum serves as an overall recommendation of award for the overall Guaranteed Maximum Price No. 2 (GMP2) – Balance of Plant (BOP) to PLW Waterworks (PLW) for the Garver-designed portions of the Wilbarger Creek Regional Wastewater Treatment Facility (WCRWWTF) Phase 1 Construction Project (PLW Job No. P5K). The BOP started advertisement on January 9, 2024; bids were received by package on February 23, 2024 (BOP 6, 8, and 11) or March 15, 2024 (BOP 1, 2, 3, 7, 9). This recommendation is based on the Final GMP 2 package submitted for review on May 22, 2024 (which reflects reception of bids by the City Team and/or PLW on the dates indicated; recommendation is also based on subsequent normalizations and negotiation of pricing).

Balance of Plant (BOP) associated with GMP2 include the following components:

- a) BOP1 Influent Facilities
- b) BOP2 Aeration Facilities
- c) BOP3 Secondary, Tertiary and Solid Facilities
- d) BOP6 Commercial Facilities
- e) BOP7 Yard Pipe Package
- f) BOP8 Electrical and Instrumentation & Control
- g) BOP9 Site Work Package
- h) BOP11 Sitewide HVAC Package

GMP2 will revise the total authorization for the PLW CMAR contract to \$247,671,315.93. This authorization will include the Guaranteed Maximum Price No. 1 (GMP1) Contract Amendment (\$45,768,402.00), and a new authorization of an additional \$201,902,913.45 of funds towards the WCRWWTF project. The total cost of work included in GMP2 is summarized by the following table:

Thus, Garver has provided their final recommendation which will enable construction to proceed; the overall construction cost for the project scope is approximately \$247,671,316.
