Regular Meeting

1. Call to Order

[ORD-0757](#) Approving an ordinance as amended on second reading with the caption reading: An Ordinance of the City of Pflugerville, Texas, amending the City of Pflugerville, Texas Code of Ordinances, Chapter 72 regarding speed limits on City Streets (Jesse Bohls Road and Cameron Road) to establish prima facie maximum speeds; providing for a penalty for a violation of Chapter 72 as a Class C Misdemeanor and a fine in an amount not to exceed \$200.00; repealing all ordinances to the extent they are in conflict; providing for severability; and providing an effective date.
- The ordinance was approved on second reading on the consent agenda.
- 4B. [2023-1138](#) Approving the minutes of the November 14, 2023 Worksession, November 14, 2023 Regular Meeting, and November 20, 2023 Special Meeting.
- The minutes were approved on the consent agenda.
- 4E. [2023-1145](#) Approving a professional services agreement with CP&Y Inc., dba STV Infrastructure, in the amount of \$244,521 to provide owner representative services associated with Kelly Lane Wastewater Interceptor, and authorizing the City Manager to execute the same.
- The item was approved on the consent agenda.
- 4G. [RES-1164](#) Approving a resolution authorizing an Advance Funding Agreement with the Texas Department of Transportation for a fixed contribution of \$10,000 associated with the East Pecan and SH 130 project, and authorizing the City Manager to execute the same.
- The resolution was approved on the consent agenda.

Mr. Mize gave an overview of staffing and volunteer hours for the event. Discussion occurred regarding the statistics from the event. - 5B. [2023-1146](#) Discuss and consider approving a Preliminary Development Agreement (PDA) with Griffin Swinerton for the development of Downtown East, and authorizing the City Manager to execute the same.

Ms. Barron gave an overview of the team that has been working on the project. Ms. Barron introduced Korin Crawford with Griffin Swinerton. Mr. Crawford gave an overview of the project moving forward. Discussion occurred regarding plans and timeline. Mr. Crawford gave an overview of facilities, retail and funds. Mr. McDonald asked about transit development. Mr. Crawford discussed the different forms of transportation planned for the development. Mr. Rogers asked about the concept drawings in the presentation and making sure the architecture will reflect old Pflugerville. Mr. Crawford stated that the drawings are conceptual. Ms. Barron answered questions from council.

Mr. Metayer moved to approve the item. Mr. McDonald seconded the motion. All voted in favor. The motion carried.

- 4F. [2023-1148](#) Approving a Water Tower License Agreement between the City of Pflugerville and Travis County Emergency Services District # 2, and authorizing the City Manager to execute the same.
