

RESOLUTION NO. 1858-21-03-09-0844

**AMENDING AND RESTATING THE CITY'S LEGISLATIVE AGENDA
FOR THE 87TH SESSION OF THE TEXAS LEGISLATURE**

WHEREAS, during the most recent legislative session of the Texas Legislature, more than 2,000 bills were filed which impacted Texas municipal operations and municipal finances; and

WHEREAS, the filing of legislation for the next biennial session of the Texas Legislature began November 10, 2020,

WHEREAS, during the upcoming 140-day legislative session, which began January 12, 2021, many significant decisions affecting Texas cities will be made by the Texas Legislature; and

WHEREAS, it is anticipated that the much of the legislation filed will propose changes that directly impact the health, safety and welfare of our citizens or impact municipal services and finances; and

WHEREAS, it is a challenge for the City of Pflugerville, given its limited resources, to effectively monitor legislation; and

WHEREAS, recent winter weather events have magnified critical infrastructure priorities in all circumstances; and

WHEREAS, the City Council adopted a Legislative Agenda for the 87th Legislative Session on September 8, 2020 as Resolution 1794-20-09-08-0761; and

WHEREAS, it is important to establish, and amend as needed, the City of Pflugerville's priorities and positions, communicate them to the legislature and advocate on their behalf.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL:

SECTION 1. The legislative positions and priorities are amended and restated as set forth in the attached Exhibit A by the Pflugerville City Council for the 87th Regular Legislative Session.


SECTION 2. This resolution shall be in full force and effect from and after its passage and approval and it is accordingly so resolved and that the City's authorized agents may act on it accordingly.

EXHIBIT A

Pflugerville City Council for the 87th Regular Legislative Session (Amended by Resolution _____)

1) GENERAL LEGISLATIVE POSITIONS:

- a) The City **supports** legislation that positively impacts:
 - i) the health, safety, and welfare of its citizens;
 - ii) home-rule municipal authority or local control;
 - iii) the City's comprehensive plan or economic development strategic plan; or
 - iv) municipal services, finances or the Texas Municipal Retirement System (TMRS).

- b) The City **opposes** legislation that negatively impacts:
 - i) the health, safety, and welfare of its citizens;
 - ii) home rule municipal authority or local decision making authority;
 - iii) the City's comprehensive plan or economic development strategic plan;
 - iv) municipal services, finances or the TMRS; or
 - v) the authority to advocate for itself or its citizens.

2) SPECIFIC LEGISLATIVE POSITIONS:

- a) The City **supports** legislation that:
 - i) creates meaningful property tax relief
 - ii) provides more state funding for public education;
 - iii) simplifies the process by which the property tax rate is adopted or makes the process more transparent; or
 - iv) establishes clear priorities for critical infrastructure for maintaining electrical power and rapid restoration.

- b) The City **supports** legislation that helps create, advance or otherwise finance projects related to:
 - i) transportation,
 - ii) water and wastewater,
 - iii) economic development,
 - iv) parks, recreation, parks, and trails.

- c) The City **opposes** legislation that:
 - i) reduces the property or sales tax base,
 - ii) impairs the City's ability to issue debt,
 - iii) creates unfunded mandates,
 - iv) requires the City to generate revenues for the State,
 - v) causes property to be appraised for less than market value or unfairly shifts the tax burden, or
 - vi) requires a mandatory election to ratify the tax rate.

- d) The City **opposes** legislation that erodes:
 - i) the management of the public right-of-way,
 - ii) fair market compensation for the use of the public's rights-of-way,
 - iii) franchise agreements, or
 - iv) jurisdiction in utility rate cases

- 3) The City will **monitor** legislation that impacts:
 - a) COVID-related economic assistance and economic recovery,
 - b) Public safety funding and tactics,
 - c) Emergency authorization authority,
 - d) Redistricting House, Senate or Congressional districts in Travis County,
 - e) LCRA and water supplies (including groundwater issues),
 - f) Emergency Service Districts (ESD), Water Supply Corporations (WSC), and any other special purpose districts (such as MMDs or MUDs), and
 - g) Capital Metro or the MoKan Corridor.

4) **COMMUNITY COLLABORATION**

- a) The City of Pflugerville is committed to collaboration with community partners and will support the Legislative Agendas of the following, except if in conflict with the City:
 - i) Pflugerville Chamber of Commerce, and
 - ii) Pflugerville Independent School District.
