Mayor Coleman indicated regarding the sports complex property, that this was Henry Pfluger's first home. He stated that Mr. Fletcher had suggested the name "Pfounders Park." City staff was to gather public input on name suggestions during the next couple of weeks. Mr. Fletcher stated that the city also has the parks at Stonehill and Highland Park that will need names. There was agreement to gather input on all three. There was continued discussion. Mr. Cooper stated that the park will become the central park and will host a range of activities.
