Discussion regarding Explore Pflugerville tourism program.

Mayor Pro Tem Weiss opened the item for discussion. Mr. Romero discussed promoting tourism in Pflugerville, brand awareness, and other city examples. Mr. Romero discussed the difference in tourism branding and reviewed the process and how the brand could be used throughout the City. Mr. Rogers discussed concerns with the use of the word explore and provided comment about other logos. Mr. McDonald discussed branding as presenting a holistic package. Mr. Romero provided information about the proposed tagline "Where Central Texas Unfolds." Discussion followed regarding what words to use and where the brand can be placed.
