BEGINNING at a ½" iron rod found at the intersection of the North right-of-way line of Rowe Lane and the East right-of-way line of Rowe Loop at the Southwest corner of that certain (5.049 acre) tract of land identified as Tract 2, as conveyed to Tiemann Land and Cattle Development, Inc. by deed recorded in Document No. 2017060975 of the Official Public Records of Travis County, Texas, and being the Southwest corner and PLACE OF BEGINNING of the herein described tract;

THENCE leaving the North right-of-way line of Rowe Lane with the East right-of-way line of Rowe Loop and with the West line of said Tiemann Land and Cattle Development, Inc. (5.049 acre) tract, N 07 deg. 50'43" E 365.50 ft. to a $\frac{1}{2}$ " iron rod found at the Northwest corner of said Tiemann Land and Cattle Development, Inc. (5.049 acre) tract, same being the Southwest corner of that certain (5.006 acre) tractvof land identified at Tract 4, as conveyed to Tiemann Land and Cattle Development, Inc. by deed recorded in Document No. 2017060975 of the Official Public Records of Travis County, Texas;

THENCE continuing with the East right-of-way line of Rowe Loop and with the West line of said Tiemann Land and Cattle Development, Inc. (5.006 acre) tract, N 07 deg. 52'21" E 367.61 ft. to a ½" iron rod with a plastic cap imprinted "RJ Surveying" found at the Northwest corner of said (5.006 acre) tract, same being the Southwest corner of that certain (5.01 acre) tract of land as conveyed to Joseph E. Hyland and Elizabeth A. Hyland recorded in Volume II660, Page 2325, of the Real Property Records of Travis County, Texas;

THENCE leaving the East right-of-way line of Rowe Loop with the North line of said Tiemann Land and Cattle Development, Inc. (5.006 acre) tract and with the South line of said Hyland (5.01 acre) tract, S 82 deg. 30'47'' E 595.09 ft. to a $\frac{1}{2}''$ iron rod with a plastic cap imprinted "RJ surveying" found at the Northeast corner of said Tiemann Land and Cattle Development, Inc. (5.006 acre) tract, same being the Southeast corner of said Hyland (5.01 acre) tract and the Northeast corner of the herein described tract;

THENCE with the East lines of said Tiemann Land and Cattle Development, Inc. (5.006 acre) and (5.049 acre) tracts, the following two (2) courses:

I.) S O7 deg. 13'43" W 363.29 ft. to a $\frac{1}{2}$ " iron rod found

2.) S O7 deg. O7'48" W 365.29 ft. to a $\frac{1}{2}$ " iron rod found in the North right-of-way line of Rowe Lane at the Southeast corner of said Tiemann Land and Cattle Development, Inc. (5.049 acre) tract and being the Southeast corner of the herein described tract;

THENCE with the North right-of-way line of Rowe Lane and with the South line of said Tiemann Land and Cattle Development, Inc. (5.049 acre) tract, N 82 deg. 56'34" W 603.78 ft. to the PLACE OF BEGINNING and containing 10.055 acres of land.





NOTES:

1. This plat lies within the City of Pflugerville full purpose jurisdiction.

- 2. Water shall be provided by Manville Water Supply Corporation and wastewater shall be provided by the City of Pflugerville.

 No lot in this subdivision shall be occupied until connected to water and wastewater facilities.
- 3. A 10-ft Public Utility Easement (P.U.E.) shall be dedicated along all street frontage.
- 4. Easement(s) dedicated to the public by this plat shall also be subject to the terms and conditions of the Engineering Design Manual (EDM) per Ordinance No .1206-15-02-24. The Grantor [property owner(s)], heirs, successors and assigns shall retain obligation to maintain the surface of the easement property, including the obligation to regularly mow or cut back vegetation and to keep the surface of the easement property free of litter, debris, and trash.
- 5. No improvements including but not limited to structures, fences, or landscaping shall be allowed in a public easement, except as approved by the City.
- 6. The property owner shall provide access to drainage and utility easements as may be necessary and shall not prohibit access for the placement, construction, installation, replacement, repair, maintenance, relocation, removal, operation and inspection of such drainage and utility facilities, and related appurtenances.
- 7. A six (6) foot wide sidewalk shall be provided on Rowe Lane and a (4) foot wide sidewalk shall be provided on Rowe Loop.
- 8. This subdivision is subject to all City of Pflugerville ordinances or technical manuals related to Tree Preservation per City Ordinance #1203-15-02-24 and City Resolution #1224-09-08-25-8A.
- 9. The assessed Community Impact Fee rate for water and wastewater is hereby accessed and established according to the City of Pflugerville Ordinance No. 1179-14-06-10. Community Impact fees for individual lots shall be paid prior to the issuance of any building permit.
- 10. This Subdivision shall mitigate post-development peak runoff rates for the 2 year, 25 year and 100 year storm events.
- 11. All electric utility infrastructure including but not limited to telephone, cable television, electric utility lateral and service lines shall be installed in accordance with the City of Pflugerville Engineering Design Manual.
- 12. The owner of this subdivision, and his or her successors and assigns, assumes responsibility for plans for construction of subdivision improvements which comply with applicable codes and requirements of the City of Pflugerville.
- 13. Construction plans and specifications for all subdivision improvements shall be reviewed and approved by the
- City of Pflugerville prior to any construction within the subdivision.

 14. Site development construction plans shall be reviewed and approved by the City of Pflugerville, Development Services,
- prior to any construction.

 15. All proposed fences and walls adjacent to intersecting public roadway right-of-way or adjacent to private access drives
- shall be in compliance with the site distance requirements of the City of Pflugerville Engineering Design Manual, as amended

 16. Wastewater and water systems shall conform to TCEQ (Texas Commission on Environmental Quality) and State Board

of Insurance requirements. The owner understands and acknowledges that plat vacation or re-platting may be required at the

- owners sole expense if plans to develop this subdivision do not comply with such codes and requirements.

 17. Detention for the site will be provided with the site development plans. The location of the ponds and drainage easement
- for both public and private detention and conveyance will be provided by separate instrument.

 18. Where applicable, the Public Parkland dedication and Park Development Fee shall be calculated at a rate required by
- the City Ordinance #1203-15-02-24.

 19. This subdivision will be subjected to a condominium declaration to be recorded in the Official Public Records of Travis County, Texas, whereby the common elements of the condominium regime shall be maintained by the condominium association created pursuant to the condominium declaration. Until the condominium association is created and if for any reason the condominium association ceases to exist, the common elements of the condominium
