

**ORDINANCE NO. \_\_\_\_\_**

AN ORDINANCE AMENDING THE CITY OF PFLUGERVILLE CODE OF ORDINANCES TITLE IX: GENERAL REGULATIONS, **SECTION 95.27 DUTIES OF THE COMMISSION**, REPLACING ALL ORDINANCES IN CONFLICT; CONTAINING A SEVERABILITY CLAUSE AND DECLARING AN EFFECTIVE DATE.

**WHEREAS**, the management of the City’s various boards, commissions, and committees has come under evaluation from the need to consider efficiency and effectiveness; and

**WHEREAS**, in July 2001, the City Council began considering the need for a beautification committee to assist with the plans for the City’s Gateway project and in September 2001, the City Council appointed a Beautification Committee; and

**WHEREAS**, in January 2003, the City Council changed the name of the Beautification Committee to Keep Pflugerville Beautiful to become affiliated with Keep Texas Beautiful; and

**WHEREAS**, the Keep Pflugerville Beautiful Committee has since made the mission of Keep Texas Beautiful as their own, by being dedicated to beautifying and improving community environments through programming and education; and addressing the areas of litter prevention, community beautification and waste reduction to promote economic development, and change visitors’ perceptions; and

**WHEREAS**, the City Council of the City of Pflugerville now finds it appropriate to extend appreciation to all members of the Keep Pflugerville Beautiful Committee, past and present, and to declare the work of the Keep Pflugerville Beautiful Committee as complete and to assign all Keep Pflugerville Beautiful efforts to the Parks and Recreation Commission ;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

I.

THAT the Code of Ordinances of the City of Pflugerville, Texas, is hereby amended by amending **Section 95.27 DUTIES OF THE COMMISSION** in which said sections shall read as follows:

**§ 95.27 DUTIES OF THE COMMISSION.**

The Commission shall make recommendations to the Council related to the Department concerning those matters set forth in the Charter of the city, Charter Sec. 8.07(c) and shall serve as the affiliate of the City of Pflugerville as a member of Keep Texas Beautiful and execute additional duties so as to maintain standing.

VII.

Severability.

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

VIII.

Effective Date.

This Ordinance will take effect upon its adoption by the City Council and publication of the caption hereof in accordance with Section 3.15(d) of the City Charter.
