RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS ESTABLISHING A RIDESHARE VOUCHER PROGRAM AND SERVICE AREA WITH RIDESHARE PROVIDERS UBER AND MARUTI

WHEREAS, in 2015, the City Council approved the creation of a Transit Development Plan (TDP) that identifies the transit needs in Pflugerville, analyzes service options and financing, provides recommendations for transit services, and complements the future high-capacity transit ervices; and

WHEREAS, in 2018, the City Council approved a TDP that established four goals for transit to 1) provide a safe, reliable, efficient, and accessible transportation option for residents of and visitors to the city of Pflugerville, 2) address the mobility needs of the residents of Pflugerville, 3) develop a local transit system that operates effectively and continues to develop regional transit options connecting the local community to the region and 4) that Pflugerville will have a regional transportation presence to ensure connectivity between emerging destinations and centers both within and external to Pflugerville and maintain a voice in regional transportation and planning cycles; and

WHEREAS, in September 2020, the City Council approved an interlocal agreement with Capital Metro to establish a transit program with Capital Metro that would provide door to door pick up service for approximately 3.3 square miles along the Pecan Street corridor from March 23, 2021 to September 30, 2022 and established metrics; and

WHEREAS, in November 2020 the City Council adopted a Transportation Master Plan with the goal of development a transit system plan for the community; and

WHEREAS, in September 2021, the City Council adopted a strategic goal to create a fiscally-sustainable city with high quality of life; and

WHEREAS, in April 2022, the City Council adopted the Aspire Pflugerville 2040 Comprehensive Plan which outlines goals for transit that Focus on multi-modal transportation options, including transit and the related economic benefits, , and

WHEREAS on August 23, 2022, the City Council approved a contract with TRIPPP Consulting services to provide rideshare services in collaboration with UBER and MARUTI; and

WHEREAS, it is anticipated that the average cost of a ride is between \$12 and \$15 within the City of Pflugerville when utilizing the UBER rideshare company.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Hereby establishes the following parameters for the rideshare program for FY23:

- 1. Ride cost will be established at four dollars (\$4)
- 2. Ten (10), \$10 vouchers will be available monthly for users to utilize the program

- 3. Vouchers are good for travel for rides with an origin and destination within the City of Pflugerville as shown in Exhibit A
- 4. Vouchers are good for origination from Tech Ridge Park and Ride to Pflugerville or destination to Tech Ridge Park and Ride from Pflugerville
- 5. Any cost of a ride over \$14.00 will be the responsibility of the rider with the exception of those riders requiring a wheelchair accessible vehicle (WAV) provided through MARUTI, then the maximum cost to the rider will be \$4 with no monthly limit on youchers.
