AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES, BY AMENDING TITLE VII TITLED TRAFFIC CODE, BY AMENDING CHAPTER 71 TITLED PARKING REGULATIONS, BY AMENDING SECTION 71.05 TITLED PARKING PROHIBITED IN CERTAIN DESIGNATED AREAS OF PFENNIG LANE; PROVIDING A VIOLATION OF SECTION 71.05 IS A CLASS C MISDEMEANOR WITH A FINE NOT TO EXCEED \$500.00; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABLITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council finds the City of Pflugerville is a Texas Home-Rule Municipality as that term is defined by Texas law;

WHEREAS, the City Council finds that conditions along portions of Pfennig Lane are not appropriate for street parking; and

WHEREAS, the City Council finds that it has the authority to restrict parking under the Texas Transportation Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Section 1. Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

Section 2. Amendment to Municipal Code of Ordinances. The City of Pflugerville, Texas Code of Ordinances, Title VII (entitled "*Traffic Code*"), Chapter 71 (entitled "*Parking Regulations*"), Section 71.05 (entitled "*Parking Prohibited in Certain Designated Locations*") is hereby amended by deleting language that is stricken (stricken) and adding language that is underlined (underlined) as follows:

§ 71.05 PARKING PROHIBITED IN CERTAIN DESIGNATED LOCATIONS.

(A) When signs are erected in the following locations reading substantially, "No Parking, Tow-Away Zone," it shall hereafter be unlawful for any person to park or stand any vehicle or trailer on the following parts of streets at any time, including but not limited to Sundays and holidays:

1) <u>E. Oxford Dr</u>. On the south side of Oxford Dr. from 230 ft. east of the centerline from its intersection with Dessau Rd. to a point 390 ft. east of the centerline of Dessau Rd.

2) Portchester Castle Path

(a) On south side of Portchester Castle Path from a point 200 ft. west of its intersection with the centerline with Mammoth Cave Blvd. to a point 365 ft. east of its intersection with the centerline of Bandelier Dr.

(b) On the east side of Portchester Castle Path from a point 300 ft. south of its intersection with the centerline of Obed River Dr. to a point 40 ft. south of its intersection with the centerline of Obed River Dr.

3) Pfluger Farm Lane

- (a) On the east side of Pfluger Farm Lane from its intersection with West Town Center Drive to a point 970 ft. south of its intersection with West Town Center Drive.
- (b)On the west side of Pfluger Farm Lane from its intersection with West Town Center Drive to a point 970 ft. south of its intersection with West Town Center Drive.

4) Terrell Lane

- (a) On the east side of Terrell Lane from its intersection with Town Center Drive to a point 800' south of Town Center Drive.
- (b)On the west side of Terrell Lane from its intersection with Town Center Drive to a point 800' south of Town Center Drive.

5) Pfennig Lane

(a) <u>On the north side of Pfennig Lane from its intersection with Swenson Farms</u> <u>Drive to its intersection with Black Locust Drive.</u>

(B) The City Manager or his designee is directed to cause to be towed away any vehicle found parked or standing in violation of Section 71.05 of this ordinance; and the owner of such vehicle shall be civilly liable to the person doing such towing for the reasonable cost thereof.

Section 3. Severability. If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

Section 4. Repealer. This ordinance shall be cumulative of all other ordinances of the City of Pflugerville, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Pflugerville except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

Section 5. A violation of Section 71.05 of the Code of Ordinances after the Effective Date of this Ordinance shall be a misdemeanor with a fine not to exceed \$500.00 as provided by Section 71.99 (Penalty) of the Code of Ordinances.

Section 6. Effective Date. This Ordinance will take effect upon its adoption by the City Council in accordance with Section 3.15(d) of the City Charter.
