**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS TO AUTHORIZE SUBMITTAL OF REGIONAL TRANSPORTATION PLAN AND TRANSPORTATION IMPROVEMENT PLAN AMENDMENTS TO THE CAPITAL AREA METROPOLITAN PLANNING ORGANIZATION (CAMPO)**

**WHEREAS**, the Capital Area Metropolitan Planning Organization (CAMPO) is the Metropolitan Planning Organization (MPO) for the area that includes Travis and Williamson Counties; and

**WHEREAS**, MPOs are designated for areas having a population greater than 50,000 as identified by the U.S. Census Bureau; and

**WHEREAS**, CAMPO was established in 1973 and is governed by the Transportation Policy Board which comprises regional and local officials; and

**WHEREAS**, CAMPO approves the use of federal transportation funds within the region, and produces both the long-range Regional Transportation Plan (RTP) and the short-range Transportation Improvement Program (TIP); and

**WHEREAS**, project sponsors are responsible for design and implementation of projects; and

**WHEREAS**, CAMPO coordinates regional transportation planning with cities and counties; and

**WHEREAS**, the City of Pflugerville is providing local funding to implement a number of projects identified in the RTP which are identified in the 4-year TIP; and

**WHEREAS**, the City of Pflugerville received voter approval to issue General Obligation Bonds for some of those projects identified in the RTP and TIP ,including improvements to Heatherwilde Boulevard, East Pecan Street, East Pflugerville Parkway, Rowe Lane, and Weiss Lane as shown in **Exhibit A**; and

**WHEREAS**, some of these projects require amendments to the RTP.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

That the City of Pflugerville authorizes the submittal of Regional Transportation Plan (RTP) and Transportation Improvement Program (TIP) amendments and authorizes Assistant City Manager Trey Fletcher to be considered the official applicant to submit these requests and make necessary assertions and representations on the City of Pflugerville's behalf.

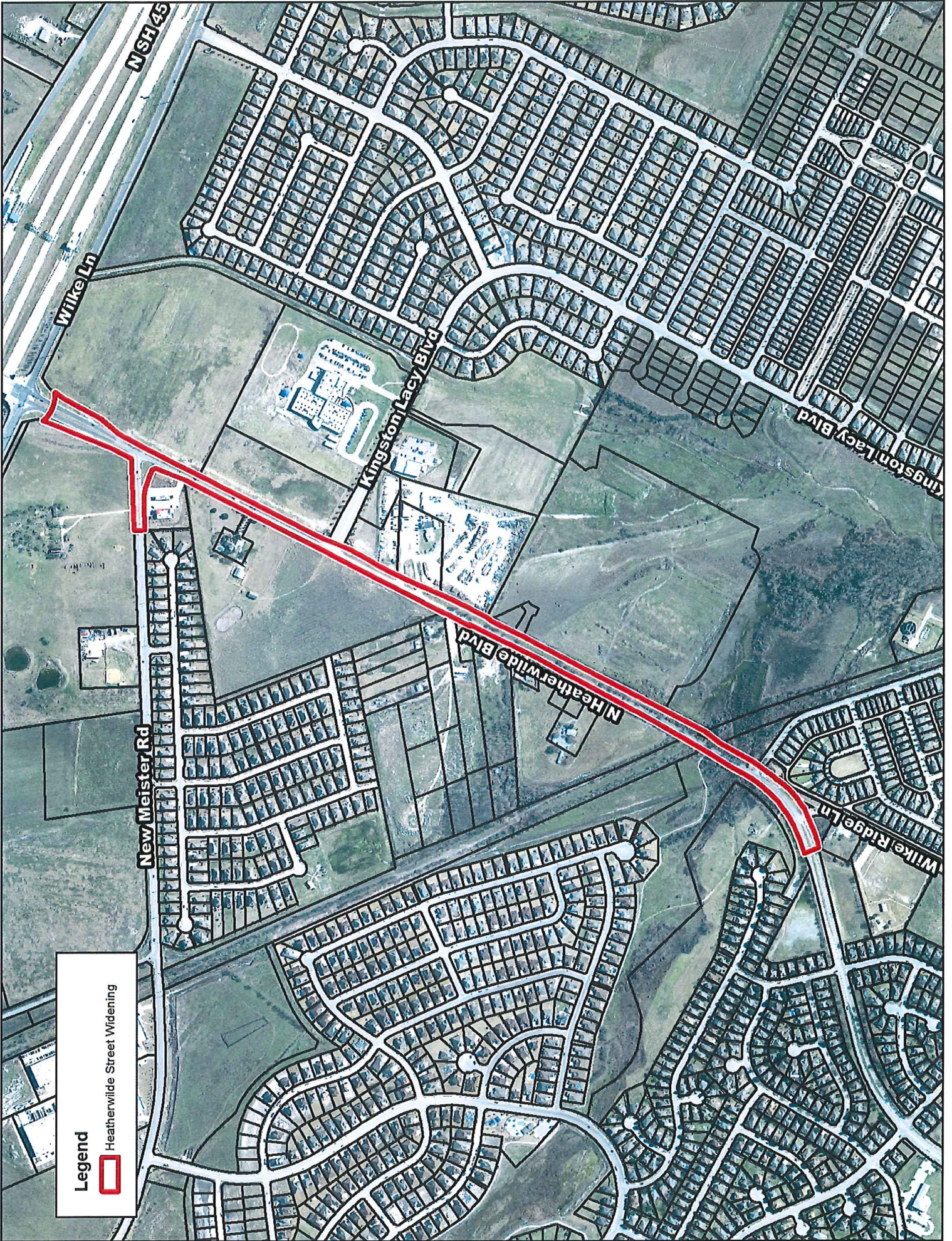

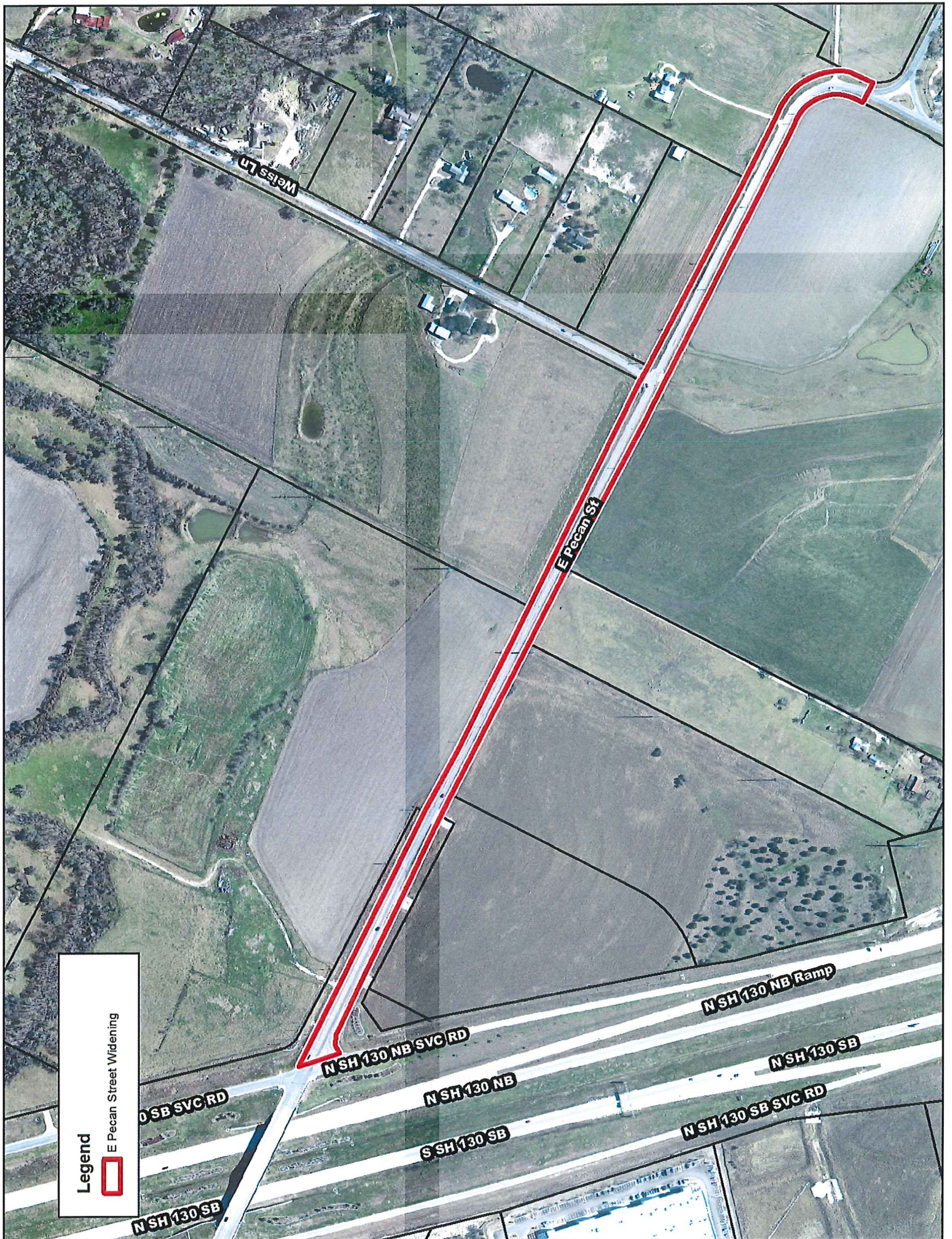




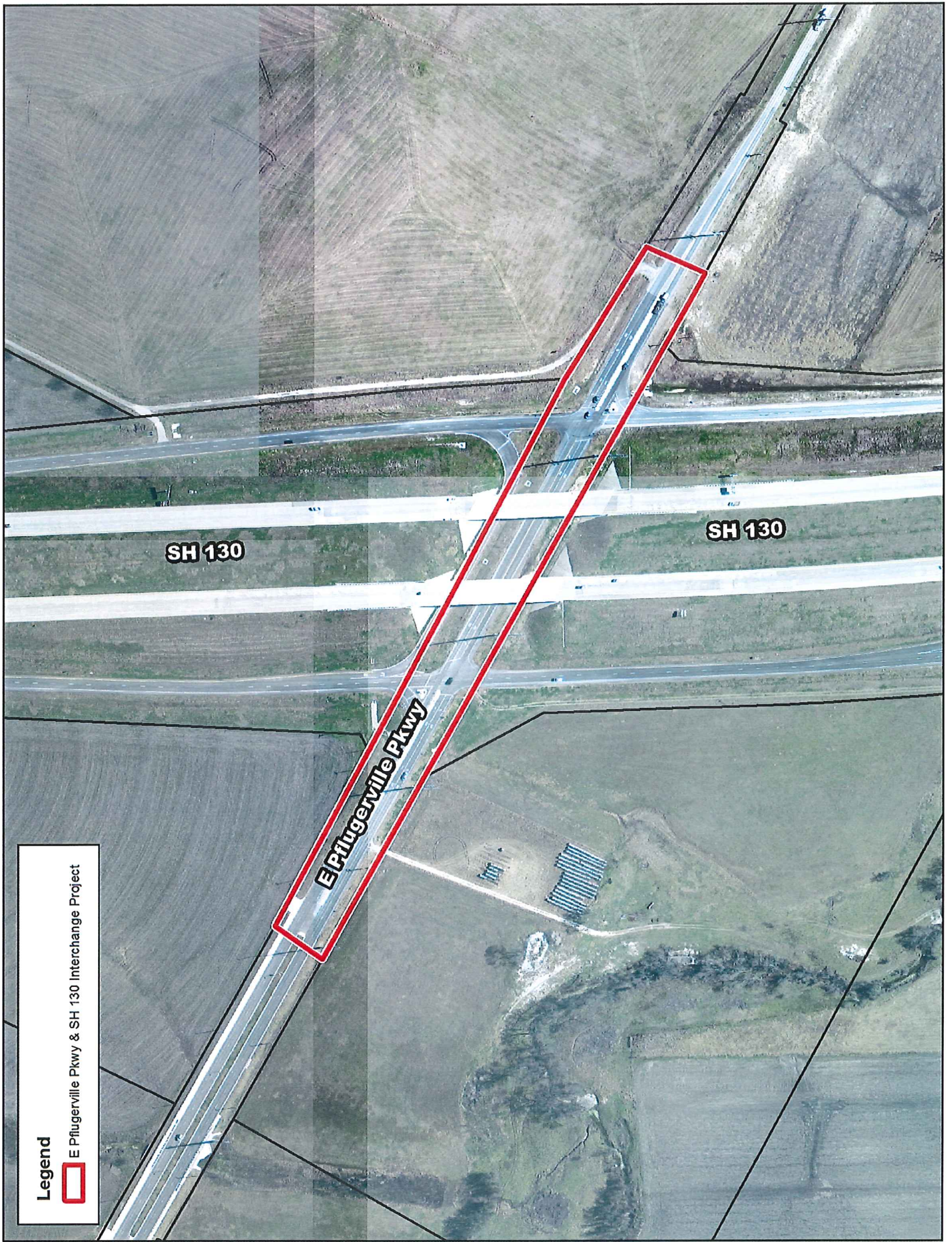

 Heatherwild Street Widening






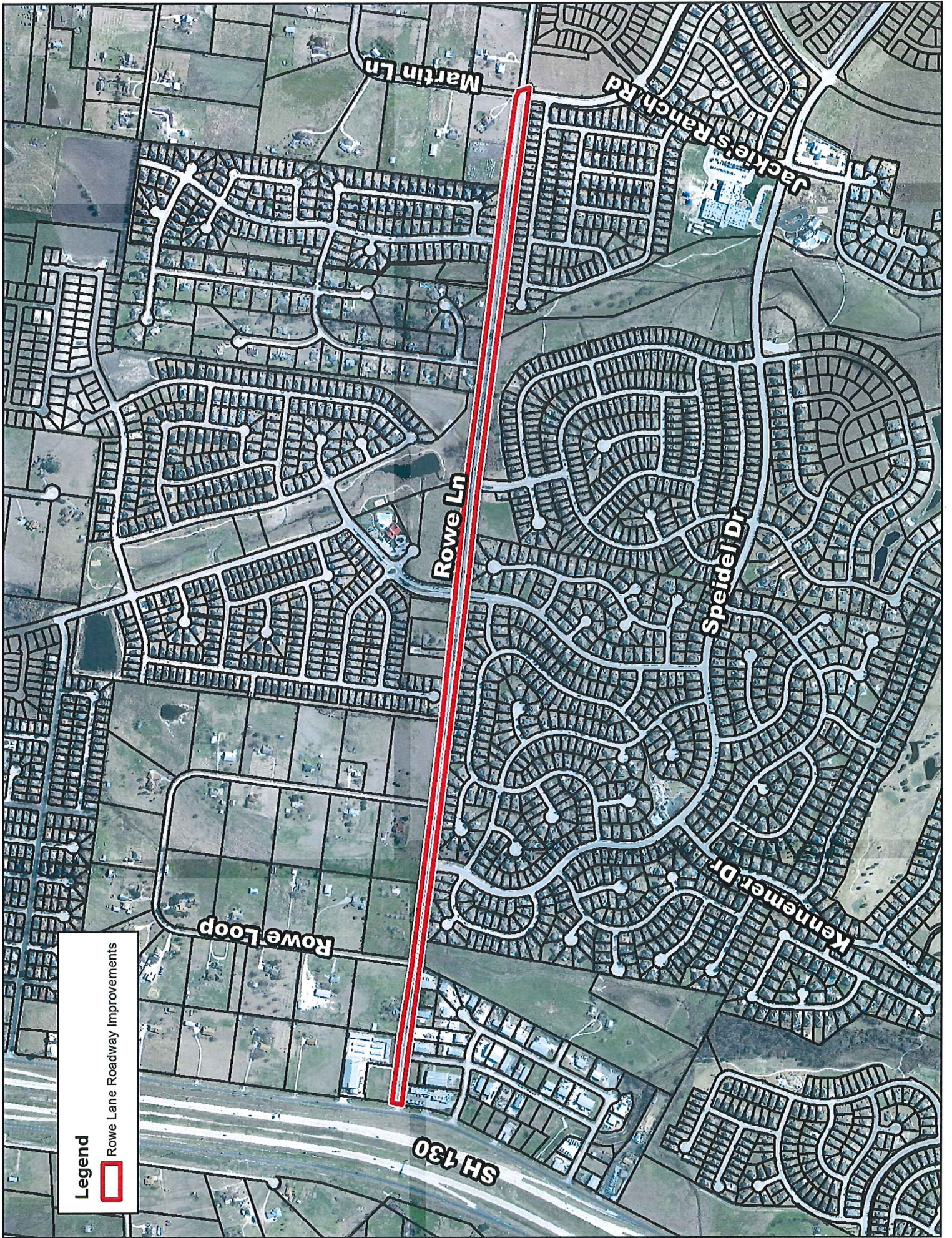

 E Pflugerville Pkwy & SH 130 Interchange Project

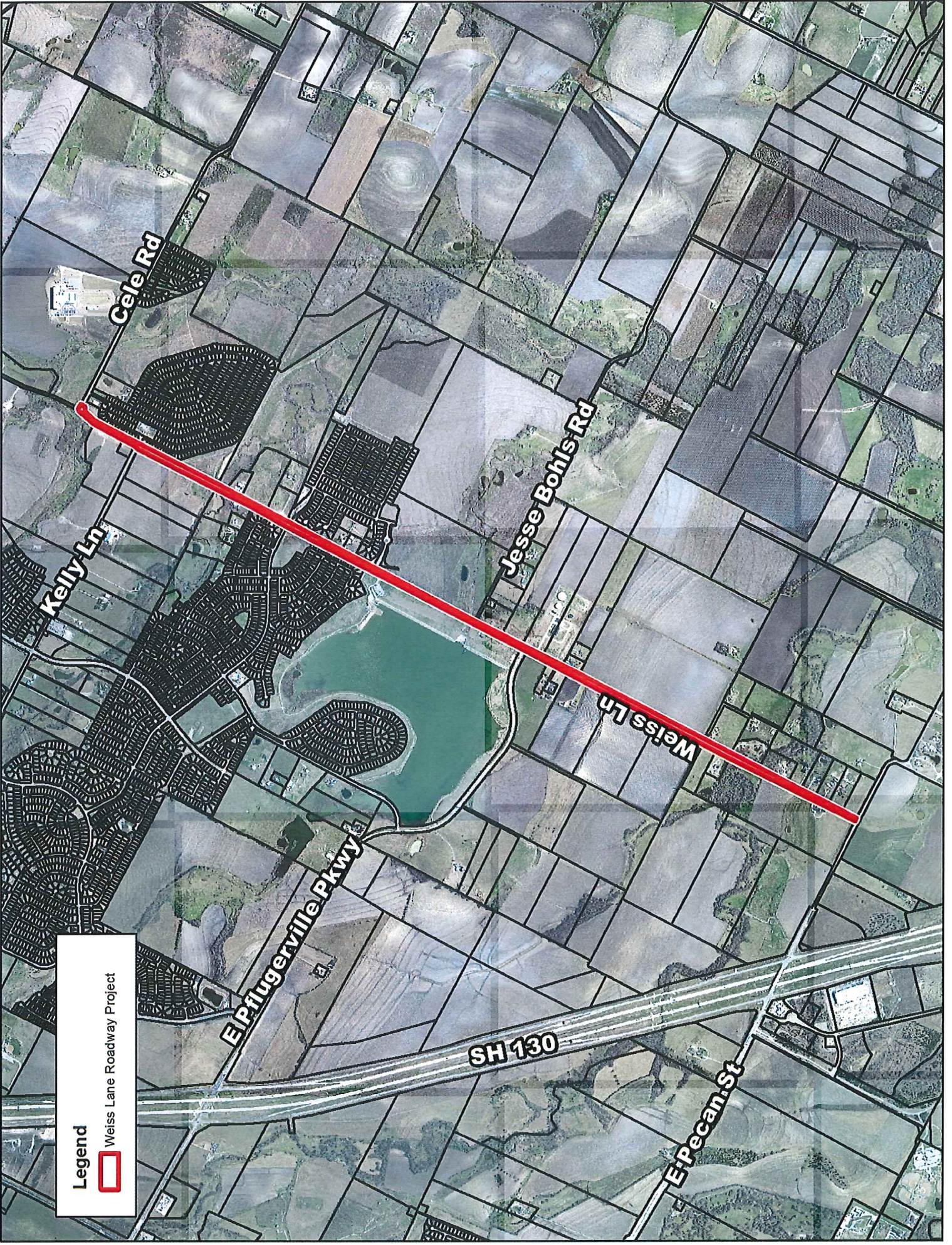




**Legend**
