

**FIRST AMENDMENT TO R-O-W AGREEMENT
BETWEEN
THE CITY OF PFLUGERVILLE
AND
PENLEY PARK HOA**

This First Amendment to R-O-W Agreement (this “First Amendment”) is made the date set forth below by and between the CITY OF PFLUGERVILLE, TEXAS, a home-rule city located in Travis County, Texas (the “**City**”) and PENLEY PARK HOMEOWNERS ASSOCIATION, a Texas non-profit corporation (the “**Association**”).

RECITALS

WHEREAS, pursuant to that certain R-O-W Agreement dated October 28, 2014, recorded under Document No. 2014163235 of the Official Public Records of Travis County, Texas (the R-O-W Agreement), the City granted the Association a license to install and maintain landscaping, irrigation, and certain authorized improvements on public rights-of-way and open space in the Reserve at Penley Park, a residential subdivision located in Travis County, Texas in and upon the “Licensed Areas” (as such term is defined in Exhibit A to the R-O-W Agreement).

WHEREAS, the City and the Association desire to add additional land to the Licensed Areas defined and presently subject to the R-O-W Agreement.

NOW, THEREFORE, the City and the Association hereby acknowledge and agree that the land described as Lots 1 and 22, Block B Penley Park Phase 3 recorded under Document No. 201600155 and depicted in **Exhibit “A”** attached hereto and fully incorporated herewith (the “Additional Land”) shall be included with and shall hereafter be a part of the Licensed Areas, as defined in and subject to the R-O-W Agreement. All terms, covenants, restrictions, and obligations set forth in the R-O-W Agreement that are applicable to the Licensed Areas are hereafter applicable to the Additional Land and all references in the R-O-W Agreement to the Licensed Areas shall include the Additional Land.

The First Amendment shall be binding on the City and the Association and their respective successors and assigns.
