# **Regular Meeting**

# 1. Call to order

Mayor Pro Tem Omar Peña called the meeting to order at 7:02 p.m. Councilmembers Wayne Cooper, Jeff Marsh and Mike Heath were in attendance. Mayor Jeff Coleman and Councilmember Starlet Sattler were absent. # 2. Opening

Mayor Pro Tem Peña led those in attendance in reciting the Pledge of Allegiance to the Flag of the United States of America.

# 3. Presentations

Mayor Pro Tem Peña and Miss Coleman provided comments. Mayor Pro Tem Peña presented the proclamation to Miss Coleman. Miss Coleman presented her cupcakes to the Council and those in attendance.

**3B.** <u>2016-5141</u> Proclamation declaring October 9-15, 2016 as National Fire Prevention Week.

Fire Chief Ron Moellenberg provided comments and urged the public to check the date on smoke detectors this year and replace those more than ten years

old. Mayor Pro Tem Peña presented the proclamation to Chief Moellenberg.

**3C.** <u>2016-5253</u> Pflugerville Downtown Association PflugerGolf 13 presentation.

Ms. Toledo presented a video on the Pflugerville Downtown Association's PflugerGolf October 10, 2016 event announcing the Pflugerville Police Department as the 2016 Pflugerville Legend Award recipient. Mr. Victor Johnson of the Pflugerville Downtown Association provided information on the newly formed Pflugerville Police Department Benevolence Fund and presented a \$5,000 donation from the Pflugerville Downtown Association and launch of the non-profit organization. Mayor Pro Tem Peña presented the proclamation. Mr. Marsh and Mr. Heath presented donations to the fund.

**3D.** <u>2016-5237</u> Presentation on \$20 adoption fees in honor of October Adopt a Dog month and the second annual Trunk or Treat event at the animal shelter.

Ms. McLendon provided information and announced the new name for the department, the Pflugerville Animal Welfare Services (PAWS) Department.

# 4. Public Hearing and Ordinance First Readings

**ORD-0324** 4A. Conduct a public hearing and consider approving the first reading of an ordinance with a caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING ORDINANCE NO. 1203-15-02-24 OF THE CITY OF PFLUGERVILLE, TEXAS, AS AMENDED, BY CHANGING THE ZONING DESIGNATION OF TWO TRACTS CONSISTING OF APPROXIMATELY 3.218 ACRES OF LAND OUT OF THE JOHN VAN WINKLE SURVEY NO. 70, ABSTRACT NO. 877, LOCATED GENERALLY NORTHWEST OF THE W. PFLUGERVILLE PKWY. AND PICADILLY DR. INTERSECTION FROM AGRICULTURE/CONSERVATION (A) TO NEIGHBORHOOD SERVICES (NS); TO BE KNOWN AS THE ISLAMIC CENTER OF PFLUGERVILLE REZONING (REZ1608-01); PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

Mayor Pro Tem Peña opened the public hearing and read the item to include the caption of the ordinance under consideration.

Dawn Brooks, 17513 Kessler Drive, voiced concerns for the space and what is proposed for development there. She stated that they have not seen a proposed plan and were told they were going to propose at 5,000 sq. ft. mosque, and since then, that they are now proposing retail space. She stated concerns for the land space and traffic. She stated that she thinks the mosque would be fine, but it is when you get into adding a retail space and additional space and parking. She stated that parking and traffic is going to be an issue. She stated that they have had problems with drainage and it is a mess in their backyards when it rains. She asked the Council to look at the land, the size and what can really be put on it. Syed Nadeem, 1200 Autumn Sage Way, stated that it has been a couple of months since he moved to Pflugerville. He stated that he feels it would be good to have accessible neighborhood services, that they only have a 7-11 and a gas station. He stated that he thinks the location is placed well and is accessible. He stated that people moving to the area are professionals and family-oriented people. He stated that he thinks it would be good to have diversity and he thinks it will be a good addition to have this. He stated to the Council that he hopes they will vote in favor of it.

Faisal Naeem, 201 Creek Ridge Lane, stated that he is a member of the Islamic Center of Pflugerville. He stated that he wants to explain to those in attendance that this is stuff that is on the way. He stated that Pflugerville Parkway is already an arterial road and they will be in compliance with whatever the City mandates. He stated that they do not intend to and cannot go against the City. He stated that with the Islamic Center, they will still have plenty of space for a retail center. He stated that they want to be able to pay for an Imam and the vision for these shops is to provide the funds to provide services for Islams and neighbors to connect and have a cohesive and loving neighborhood. He stated that they have been located at Windermere and Pecan, and the number of churches that have reached out is amazing.

Jennifer Harris, 909 Palitine Lane, stated that she respects his desire for a place of worship. She stated that her home is next to the gate for the Pflugerville Independent School District's agriculture building. She stated there are noise issues and she doesn't see how the ag building would not bother the mosque. She stated that it is very noisy and there is tons of traffic back there.

Mayor Pro Tem Peña stated that the following people did not wish to speak but asked that their opposition or support be noted for the record.

Abdul Kham, 18424 Star Gazer Way, stated that he was at the last hearing. He stated that there were lots of concerns for the traffic, etc. and those issues shouldn't be mixed with the rezoning that we are hearing. He stated that we are talking about a small piece of land. He stated that having a small store to be self-sustaining for the mosque is important. He stated that the mosque has a huge maintenance cost. He stated that he is really happy to have the Islamic Center here and he is looking forward to it. He stated that the traffic should be minimal but that he thinks there should be a traffic signal. He stated that they should probably work on that issue separately.

Charles Deus, 17804 Regis Drive, stated that this center will be in his back yard and he fully supports it. He stated that maybe having a mosque there will motivate the Pflugerville Independent School District to keep the kids quiet and may accommodate improved drainage. He stated that he fully supports and welcomes the diversity.

Khurram Shahzad stated that he lives off Picadilly. He congratulated the City of Pflugerville, Council, neighbors and citizens for being ranked #12 by Money Magazine. He stated that this speaks volumes that a lot of good works are taking place in the city here. He stated that before buying the property, they had several meetings with the City's planning and engineering departments. He stated that after discussion and the City carefully looking at the plans, they advised the Islamic Center that this would be a good spot for the mosque and what we were planning to do with the retail center. He stated that they carefully vetted the property. He stated that they intend to follow the letter of the law and will basically be following it to its spirt. He stated that he lives in the neighborhood and they understand the concerns of the neighbors. He stated that anyone can talk with the neighbors of the Windermere center. He stated that he is completely in support and appreciates the Council's time.

Roland Gutzky, 909 Palitine Lane, stated that he does not have problem with the Islamic Center, but has concerns regarding the retail center regarding traffic, hours and noise. He asked why they would need retail to support this new site. He stated that the lot is not wide enough to negotiate more than a couple of cars.

There were no additional requests to speak at the public hearing. Mr. Cooper made a motion to close the public hearing. Mr. Heath seconded the motion. All voted in favor. The motion carried.

Mr. Cooper made a motion to approve the zoning as presented. The motion died for lack of a second.

Mr. Heath asked regarding the zoning and development process. Mr. Hyde provided information and stated Ms. Barron might be able to provide additional information. Mr. Cooper provided information on zoning being to approve a proposed land use for the property. Ms. Barron answered questions of the Council. She noted that gas station is not allowed in this category and that they generally see smaller day-time businesses in this zoning category. She stated that lighting, parking, and drainage are considered with every site development application.

Mr. Cooper made a motion to approve item 4A as presented by staff, to change the zoning as presented. Mr. Marsh seconded the motion. All voted in favor. The motion carried. The ordinance was approved on first reading as presented.
