Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

The City of Pflugerville is a fast growing suburban community that is home to over 56,000 residents. Pflugerville traditionally has been a suburban bedroom community, but as of today it is quickly becoming a full service city; providing not only places to live but to work, shop and play.

The City's overall development goal is to support the key focuses outlined in the Consolidated and Annual Action Plan. In 2015, Pflugerville continued its efforts to expand choices and opportunities for residents by providing youth scholarships for city recreation programs, and improvements to public infrastructure and facilities. The City completed several projects outlined in the PY2015 Action Plan, including an a primary project identified in PY2014 Annual Action Plan. The projects completed were the youth recreation scholarships and phase I of the sidewalk improvement project. The completed projects focused on the efforts to provide for public service as well as improvements to public infrastructure located at the Rec Center, Foothill Farms Loop and Edgemere Drive. The City opted to place the Edgemere sidewalk project on hold in PY2014 an effort to consolidate projects and utilize funding more efficiently for PY2015.

Overall, the City of Pflugerville has demonstrated measurable progress in efforts to launch projects outlined in the PY2015 Annual Action Plan. In some cases, primary projects were dropped due to changes in property availability and therefore an amended 2015 Action Plan was completed in the summer of 2016 to identify additional projects anticpated to be funded through the used of CDBG funds. Additional projects are underway and will continue to be pursued in order to fulfill the needs of the community.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

In the 2015-16 program year, fifty-three (55) children of low to moderate income backgrounds were approved for youth recreation scholarships to aid participation in eligible recreation programs. Forty-three (43) of the approved children utilized the scholarship. The youth scholarship program was available for a variety of recreation programs however programs such as the Pflugerville Summer Pfun Camp, and swim lessons were the most popular programs utilized by residents. The total cost for the program was \$5,862.00.

Phase I of the Sidewalk Improvements project neared completion in Fall of 2016. CDBG Funds were used to replace, add and improve the sidewalk system at Edgemere Dr and a connecting sidewalk was constructed along Foothills Farms providing for additional safe pedestrian access along this roadway which provides access to the Travis County Health & Human services site. Furthermore, CDBG funds were utilized to create a new sidewalk and accessible ramp and entrance at the rear entrance (west) of the Recreation Center in an effort to improve accessibility for senior citizens and persons with disabilities. Final closeout of the sidewalk preojcts are expected by the end of calendar year 2016 with the final installation of an accessible door to the Recreation Center. The total cost for the project was \$94,801.24.

One of the original projects anticpated to be completed within PY2015 was the acquisition of parkland along Parkway Drive. Upon completion of the Action Plan the property anticpated to be acquired was purchased by another party and therefore no longer available. The loss of this project required the City to reallocate funds and pursue other projects that met the objectives of the CDBG program. In the summer of 2016 the City submitted an amended Action Plan identifying new projects to be pursued. Design is currently underway for the first of the additional projects identified, Gatlinburg Sidewalk Improvements, and is anticpated to be completed in the Spring of 2017. The other project identified within the Amended 2015 Action Plan, Senior Park and Bohls Park, will not be pursued as a CDBG project by the City because after further discussions with HUD it was determined that unless the park was restricted to the use by senior citizens exclusively federal funding could not be utilized for the park. The City will continue to pursue projects that meet the objectives outlined in the City's five year Consolidated Plan and the

bjectives of the CDBG program.

Narrative

Infrastructure and public facility CDBG projects, such as phase one (1) of the Sidewalk Improvements project, are limited to tract and block groups that have a threshold of LMI persons/families of 41.44% or higher. The Sidewalk Improvements project encompassed tract 1860 block group 1 (Edgemere), tract 1860 block group 2 (Foothills Farm) and Tract 1841 block group 4 (Senior Recreation Center).

Projects such as the youth scholardship program are applicable to each tract and block group in Pflugeville. To receive the scholarship award, a child has to meet all requirments listed in the application to qualify, regardless of where they reside within city limits. Furthermore, CDBG projects for the presumbed LMI such as Seniors and Disabeled indviduals are applicable to all tract and block groups.

In February of 2015, the City adopted an updated Unified Development Code (UDC). The UDC is document outlining the required regulations for all development within the City. With the update, the City added a variety of housing options in order to provide a greater mix of housing opportunities within the community. This included allowing for greater flexibility in lot sizes (small to large lots), housing types (single family, multi-family, condominiums, and townhomes) as well as clearly defining the architectural and other building requirements. This provides developers the opportunity to construct affordable housing by allowing smaller residential development with greater overall density whether it be for smaller single family lots or higher density multifamily project. Since the adoption of the updated UDC development has continued in Pflugerville primarily for the more affordable market and flexibitliy in design standards.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

Potential obstacles to meeting underserved needs include: rapid population growth, need for transportation to existing services, access to affordable recreation facilities and programs, rising cost of housing. While population growth will occur Pflugerville has worked through various planning processes to help manage that growth over time, addressing water, wastewater, parks, trails, land use, housing and a multitude of other issues that coincide with a rapidly growing city. The projects selected are to complement the long term plans for a growing city that aid in meeting underserved needs of the low to moderate income population. Within PY 2015 the selected and completed projects were chosen to help to provide more affordable and accessible facilities and infrastructure within the community.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The City utilizes community services provided by Travis County for the remediation of lead based paint in Pflugerville's housing supply. Approximately 226 homes within the City of Pflugerville were constructed during the time when lead based paint was accepted for use. The City will continue to utilize Travis County Health and Human Services and Veterans Services, which receives funds through State grants and the Travis County General Fund to provide limited lead based paint remediation on houses built before 1978 where small holes in the wall or similar acts could cause additional lead exposure.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

Approximately 10.4% of Pflugerville residents live in poverty (ACS 2014 5 year estimate). Female headed households with children are particularly affected by poverty. The City's anti-poverty strategy is based on attracting a range of businesses and providing workforce development and a mix of uses throughout the community that are supportive of each other reducing or eliminating the need to find housing, employment or services outside of the community. These strategies are reflected through the City's Unified Development Code (UDC) and policies of the Pflugerville Community Development Corporation for attracting employment to the community.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The key departments and agencies that are involved in the implementation of the plan are described below.

Public Sector

City of Pflugerville, Planning Department

The Planning Department is responsible for the administration of the City's programs funded by entitlement grants; Community Development Block Grant (CDBG). The office has primary responsibility for managing and implementing the City's Consolidated/Annual Action Plan programs and related documents.

City of Pflugerville, Finance Department

The City Finance Department manages the entitlement grants (CDBG) procurement processes for commodities, professional services and construction. Expertise in the area of federal standards has been created within the department. The department submits all financial reports, including the SF-425.

Travis County Health & Human Services and Veterans Services Department (TCHHS/VS)

TCHHS/VS offers a variety of Services to Pflugerville and Travis County residents including:

- Utility, Rent and Mortgage Assistance
- Family Assistance
- Children's Services
- Senior Services
- Public Health Services
- Emergency Services

Coordination

The City is committed to continuing its participation and coordination with federal, state, county and local agencies as well as with the private and non-profit sector, to serve the needs of target income individuals and families in the community. The City will continue to work with the area service providers as well as the building industry to address housing and community needs.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The City has been working to improve communications with the social services within our community as well as continue to learn and open dialogue with public and private housing agencies within the central Texas region. The City consults with various social service agency before and after the selection of projects to determine if the needs are still the same as originally identified and then recommended adjustments are made accordingly, while maintaining the goals of the Consolidated Plan as well are being mindful of the budget constraints.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

People of protected classes need quality information about all neighborhood and housing options that are available to them, as well as the tools to overcome real and perceived barriers in the housing market.

In response to these impediments, the City of Pflugerville has prioritized the following as actions to be taken to achieve fair housing choice and equal opportunity:

- The City of Pflugerville will provide staff with the latest training and education on the fair housing regulations.
- City staff will work with HUD to provide better information about needs of persons with special needs and disabilities.
- The Community Development Block Grant ("CDBG") has listed infrastructure projects to accommodate persons with disabilities and special needs. The City will allocate CDBG funds to update sidewalks to ADA standards, and improve pedestrian connections to reduce barriers for the disabled.
- The City of Pflugerville will refresh the community development website to provide links to local, state, and national housing authorities. Housing authorities that will be available online are the Department of Housing and Urban Development ("HUD"), Texas Workforce Commission ("TWC") and Texas Department of Housing & Community Affairs ("TDHCA").
- City staff will make publicly available information and forms on fair housing readily available to people with special needs and limited English proficiency.
- City staff will provide Fair Housing complaint forms online that will provide information about

the complaint process. The City will also distribute hard copies to local public service agencies to aid residents in filing a complaint with HUD.

• Texas Department of Housing and Community Affairs requires five hours of approved fair housing training for architects, developers, engineers, management companies responsible for fair housing compliance. City staff will provide information for TDHCA recommended fair housing training via the City of Pflugerville community development website.

As the lead agency for the development and implementation of the Consolidated/Annual Action Plan, the Planning department implements standard policies and procedures for monitoring the implementation of CDBG projects.

Monitoring activities included weekly staff meetings to discuss tasks of the CDBG projects, weekly site visits to project locations, and close out interviews with contracted construction employees. Additionally, there is close coordination with other city departments regarding the progress of CDBG projects such as the Youth Scholarship Program.

These monitoring activities met compliance with program regulations and compliance with financial requirements.

Citizens are invited to comment on all performance reports. Notice of reports are issued through the local newspapers, the City website, City's electronic newsletter, information placed at the Public Library as well as the Travis County Community Center. Notices are issued at the beginning of the comment period as well as throughout the fifteen day review and comment period.

At the December 13th City Council meeting, the accomplishments of PY2015 will be reviewed with City Council during a public hearing.

No public comments have been received, as of the published date of the CAPER.

Specify the nature of, and reasons for, any changes in the jurisdiction's program objectives and indications of how the jurisdiction would change its programs as a result of its experiences.

The City amended the 2015 Action Plan to accomodate the changes in land availability for the originally anticpated parkland acquisition. In Pflugerville, there are very few areas in which at least fifty percent (50%) of the residents or areas are of LMI and therefore Pflugerville was granted an exception by HUD that allows the City to plan projects in areas that have a LMI threshold of 41.44%.

The amended 2015 Action Plan was updated to add two projects, Gatlinburg Sidewalk and Senior Park at Bohls Park. The new projects focused on infrastructure and facilities that would address the need for improved mobility in the City's infrststructure and a project that would helpaddress the growing senior population. Unfortunately, as discussed previously, the Senior Park at Bohls Park after submittal was determined to not meet all of the federal objectives of the CDBG program.

In the summer of 2016 City Council approved the amended 2015 Annual Action Plan which addressed the needs LMI persons as required by the five year Consolidated Plan.
