RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS APPROVING A COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT FOR PROGRAM YEAR 2015.

**WHEREAS,** the City of Pflugerville has become a Community Development Block Grant (CDBG) entitlement community as provided by the U.S. Department of Housing and Urban Development; and

**WHEREAS,** as an entitlement community, the City prepared and submitted a 2014-2019 Consolidated Plan that details the goals and objectives to be implemented to address community needs in the areas of affordable housing, homeless services, special needs population, and community and economic development needs; and

**WHEREAS,** as an element of the Consolidated Plan, the City must prepare and submit an Annual Action Plan detailing the activities to be undertaken annually to address the goals and objectives outlined in the Consolidated Plan; and

WHEREAS, the City of Pflugerville adopted a Citizen Participation Plan in accordance with the requirements established by the U.S. Department of Housing and Urban Development to encourage citizen participation with emphasis for participation by persons of low- or moderate-income, particularly residents of predominately low- and moderate-income neighborhoods, slum or blighted areas, and areas in which the grantee proposes to use CDBG funds; and

**WHEREAS,** the City Council held a public hearing on December 13, 2016 to receive input from citizens and agencies having interest in the CDBG program; and

**WHEREAS**, the proposed plan was made available for comment online, at the Pflugerville Public Library, and at the Travis County Community Center from November 28, 2016 to December 13, 2016; and

**WHEREAS**, the City has met the requirements for citizen participation in preparation of this report and has allowed the opportunity for persons or agencies to identify needs and present concepts to help meet those needs through the CDBG program, as prescribed by the U.S. Department of Housing and Urban Development; and

**WHEREAS,** the CDBG Advisory Committee voted on December 5, 2016 to recommend approval of the 2015 Consolidated Annual Performance and Evaluation Report.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

That this Program Year 2015 Consolidated Annual Performance and Evaluation Report (CAPER) attached as Exhibit A, is approved.

**BE IT FURTHER RESOLVED** that the City Manager is authorized to submit the Consolidated Annual Performance and Evaluation Report (CAPER) to the U.S. Department of Housing and Urban Development for their review and approval.
