**RESOLUTION IN SUPPORT OF A REQUEST FROM THF PFLUGERVILLE MEADOWS, LLC FOR
AN APPLICATION SEEKING 2017 COMPETITIVE 9% HOUSING TAX CREDITS WITH THE
TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS FOR THE PFLUGERVILLE
MEADOWS APARTMENT AFFORDABLE RENTAL HOUSING PROJECT.**

WHEREAS, THF Pflugerville Meadows, LLC has proposed an acquisition and rehabilitation for affordable rental housing located at 201 Meadow Lane, Pflugerville, Texas 78660 named Pflugerville Meadows in the City of Pflugerville; and

WHEREAS, THF Pflugerville Meadows, LLC intends to submit an application to the Texas Department of Housing and Community Affairs (TDHCA) to compete for 2017 Housing Tax Credits for the Pflugerville Meadows affordable rental housing project (the "Development"); and

WHEREAS, in accordance with Section 11.9(d)(1) of the TDHCA's 2017 Governor Approved Qualified Allocation Plan, an application may qualify for points for a resolution voted on and adopted from the governing body expressly setting forth that the City of Pflugerville supports the application or Development; and

WHEREAS, THF Pflugerville Meadows, LLC has requested a partial waiver of development fees from the City in the amount of \$10.00 for Pflugerville Meadows as a commitment of Development funding from the City of Pflugerville, Texas; and

WHEREAS, the City Council of the City of Pflugerville, Texas has the authority to waive development fees on property located within the City limits of Pflugerville.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Pflugerville, Texas that:

The governing body of the City of Pflugerville, Texas, hereby adopts this resolution as evidence to its commitment of funds in the amount of \$10.00 to be provided to the development in the form of a waiver of development fees.

FURTHER RESOLVED, that the City of Pflugerville, acting through its governing body, hereby confirms that it supports the proposed Development located at 201 Meadow Lane and that this formal action has been taken to put on record the opinion expressed by the City Council on February 14, 2017; and

FURTHER RESOLVED, that as provided for in §11.3(b) of the Qualified Allocation Plan, it is expressly acknowledged and confirmed that the City of Pflugerville has more than twice the state average of units per capita supported by Housing Tax Credits or Private Activity Bonds; and

FURTHER RESOLVED, that the City of Pflugerville hereby supports the Pflugerville Meadows Apartments rehabilitation project, and confirms that its governing body has voted specifically to approve the construction and/or rehabilitation of the Development and to authorize an allocation of Housing Tax Credits for the Development pursuant to Tex. Gov't Code §2306.6703(a)(4); and

FURTHER RESOLVED, that for and on behalf of the Governing Body, the City Manager is hereby authorized, empowered, and directed to certify these resolutions to the Texas Department of Housing and Community Affairs.

This resolution shall take effect immediately and upon passage.
